Governor Dannel P. Malloy signed the following legislation of the 2018 Regular Session on June 11:

HB 5532 SA 18-19	AN ACT AMENDING THE CHARTER OF THE GROVE BEACH POINT ASSOCIATION. This bill is effective from passage.
HB 5555 SA 18-20	AN ACT CONCERNING THE YOUTH VIOLENCE INITIATIVE. This bill is effective from passage.
HB 5478 PA 18-126	AN ACT CONCERNING TECHNICAL AND MINOR CHANGES TO THE LABOR DEPARTMENT STATUTES. This bill takes effect October 1, 2018.
HB 5477 PA 18-127	AN ACT CONCERNING STATE V. MCCAHILL. This bill is effective from passage.
HB 5471 PB 18-128	AN ACT CONCERNING VICTIM'S RIGHTS AND RESTITUTION This bill takes effect October 1, 2018.
HB 5335 PA 18-129	AN ACT CONCERNING THE ALIGNMENT OF THE COORDINATED STATE-WIDE READING PLAN WITH THE STATE'S TWO-GENERATIONAL INITIATIVE. This bill takes effect July 1, 2018.
HB 5481 PA 18-130	AN ACT CONCERNING CHANGES TO THE STATE PERSONNEL ACT. This bill takes effect October 1, 2018.
HB 5503 PA 18-131	AN ACT CONCERNING THE KILLING OR INJURING OF SEEING EYE DOGS AND ASSISTANCE DOGS. This bill is effective from passage.
HB 5487 PA 18-132	AN ACT CONCERNING THE CONTINUANCE OF A NONCONFORMING USE, BUILDING OR STRUCTURE. This bill takes effect July 1, 2018.

HB 5528 PA 18-133	AN ACT DECREASING THE MEMBERSHIP OF THE COMMISSION ON WOMEN, CHILDREN AND SENIORS. This bill is effective from passage.
HB 5557 PA 18-134	AN ACT CONCERNING THE COMPETENCY OF A DEFENDANT TO STAND TRIAL. This bill takes effect October 1, 2018.
HB 5563 PA 18-135	AN ACT CONCERNING ROBO CALLS AND SPOOFING. This bill takes effect October 1, 2018.
SB 175 PA 18-137	AN ACT IMPLEMENTING THE RECOMMENDATIONS OF THE AUDITORS OF PUBLIC ACCOUNTS. This bill has various effective dates.
SB 185 PA 18-139	AN ACT CONCERNING THE LEGISLATIVE COMMISSIONERS' RECOMMENDATIONS FOR TECHNICAL REVISIONS TO THE EDUCATION AND EARLY CHILDHOOD STATUTES. This bill has various effective dates.
SB 193 PA 18-141	AN ACT CONCERNING REVISIONS TO DEPARTMENT OF CONSUMER PROTECTION STATUTES. This bill has various effective dates.

HB 5591 PA 18-136	AN ACT CONCERNING THE MACHINERY RENTAL SURCHARGE RATE, CERTAIN MUNICIPAL FILING FEES AND THE PROPERTY TAX EXEMPTION FOR CERTAIN PAINT MIXING MACHINERY AND EQUIPMENT. This bill takes effect July 1, 2018.
SB 302 PA 18-148	AN ACT CONCERNING TELEHEALTH SERVICES. This bill takes effect July 1, 2018.
SB 303 PA 18-149	AN ACT CONCERNING OUTPATIENT CLINICS, URGENT CARE CENTERS AND FREESTANDING EMERGENCY DEPARTMENTS. This bill takes effect October 1, 2018.
SB 304 PA 18-150	AN ACT ESTABLISHING A MATERNAL MORTALITY REVIEW PROGRAM AND COMMITTEE WITHIN THE DEPARTMENT OF PUBLIC HEALTH. This bill takes effect October 1, 2018.
SB 377 PA 18-151	AN ACT AUTHORIZING AGENCY CAPTIVE INSURANCE COMPANIES. This bill takes effect July 1, 2018.
HB 5208 PA 18-159	AN ACT CONCERNING MAMMOGRAMS, BREAST ULTRASOUNDS AND MAGNETIC RESONANCE IMAGING OF BREASTS. This bill takes effect January 1, 2019.

HB 5149 PA 18-171	AN ACT CONCERNING SOBER LIVING HOMES. This bill is effective October 1, 2018.
SB 198 SA 18-21	AN ACT ESTABLISHING A TASK FORCE TO STUDY METHODS OF DEVELOPING, EXPANDING AND IMPROVING THE INSURANCE INDUSTRY WORKFORCE IN THIS STATE.

As of this date, the Governor has signed one hundred and sixty-three (163) bills, vetoed four (4) bills, and left unsigned one (1) bill of the 2018 Regular Session.
