Mr. Ruszczyk:

In the wake of the brutal and senseless killing of twenty children and six adults at the Sandy Hook Elementary School in Newtown, people from across the world have been moved to make millions of dollars in charitable contributions. In response to this outpouring, dozens of organizations and individuals have established funds or conducted fundraising events to collect these contributions. Like so many, we are heartened by this outpouring of sympathy and support.

Consistent with the responsibilities to oversee charitable activities and fundraising in Connecticut, we are requesting information about your organization's fundraising and charitable efforts. In all circumstances, donors need information to help make informed giving decisions and to understand the purposes for which their gifts will be used. This is particularly important - and challenging - when so much money is being raised so quickly.

To promote transparency and encourage further giving, we request that you provide responses to the questions in the attached document. We understand that you are currently responding to needs of the victims, and do not want to distract you from your efforts. Accordingly, we have attempted to limit our questions to those that can be answered with limited effort and disruption, but which will provide important information to the public at this stage of the relief efforts. In the coming months, we expect to reach out to you for additional information, including more detail about how donations have been expended and the steps taken to prevent fraud and/or misuse of resources. This is a voluntary request for information, but we strongly urge you to participate so this important information can be provided, through our websites or other means, to the giving public.

If you are unable to provide responses by this date because of your ongoing relief efforts or for some other reason, please let us know. How does your organization determine the need for assistance?
7. Does your organization have a plan in place on how to use any surplus funds not sper for Sandy Hook tragedy? If so, please describe that plan.
