On behalf of Sandy Hook Volunteer Fire & Rescue Co, Botsford Fire Rescue, Hawleyville Fire & Rescue, Dodgingtown Volunteer Fire Co, and Newtown Hook and Ladder Co, *please accept the enclosed check for your portion of the proceeds of The Green Ribbon Ride, for your use in any way you see fit.*

Early in January 2013, Sandy Hook Fire gathered the other Newtown Fire houses together to coordinate putting on a motorcycle tribute ride for the 26 Angels and for the efforts of the First Responders. During that process and because of the expected size of the event, Assistant Chief SHVF Anthony Capozziello and Greg Gnandt the creator of the Copper Stars Memorial, requested Fred Garrity, Jr to direct the event.

During the planning stage it was resolved to first decide whom the recipients of any proceeds of the event would be, and secondly, to decide the amount to be given to each. The families of the 26 Angels were the first group chosen and also that they should receive the largest share. Also chosen was the Sandy Hook Family Healing Fund for the survivors, the Police, EMS, and each of the five Newtown Fire Departments.

With the main focus of the event being a tribute, it was noted that no one group would receive any huge amount of money, so it was further agreed by all, to make donations on behalf of the children's memory to two local charities helping children; The Center for Women and Families helping victims of Child Abuse and Al's Angels helping Children with Cancer and severe financial hardship and their families at the Holidays.

The amounts were 40% for the 26 Families, 25% for the five Newtown Fire Departments (5% ea), 5% for the Sandy Hook Family Healing Fund, 5% for Newtown Police, 5% for Newtown EMS, and 20% for the local children's charities (10% ea)
