Dear Mr. Spees and Ms. Stromstad:

This letter revises the schedule set forth in Connecticut General Statutes § 19a-486b(a) in connection with the hospital conversion dockets OHCA Docket No. 15-32017-486 and Attorney General Docket No. 15-486-02 currently pending in the Department of Public Health, Office of Health Care Access ("OHCA") and the Office of the Attorney General (the "OAG"). The Applicants are Greater Waterbury Health Network, Inc. ("GWHN") and Prospect Medical Holdings, Inc. ("PMH").

Due to the press of business at OHCA and the increased responsibilities of its review, OHCA has requested an extension of the 120-day review period as set forth below. The OAG agrees that the 120-day review period should be extended for this docket.

Therefore, pursuant to Conn. Gen. Stat. § 19a-486b(a) and after discussion, the parties have agreed to the following schedule for completion of the Greater Waterbury Health Network, Inc. and Prospect Medical Holdings, LLC hospital conversion review. Specifically, the parties agree to extend the 120-day review period set forth in § 19a-486b(a) until <u>July 15, 2016</u>. If it becomes apparent that we cannot complete the Greater Waterbury Health Network, Inc. and Prospect Medical Holdings, LLC review by the date established above, all parties will convene at the earliest opportunity to agree upon a revised final decision completion date.
