Dear Mister Hawes and Mister Lazarus,

I am a self-employed general internist in independent practice with Southbury Medical Associates in Southbury, and a member of the staff of Waterbury Hospital since 1997. Waterbury Hospital has been our primary hospital during that time. We have admitted the vast majority of our patients there over the years.

I am writing in support of the pending acquisition of Waterbury Hospital by Prospect Holdings. As a self employed physician, without financial connections to either Waterbury Hospital or Prospect Holdings, I think my opinion may be somewhat unique and of use to you in your deliberations.

Over the last decade or so, I have watched the facilities and the services at Waterbury Hospital suffer greatly from needless local competition. The only beneficiaries of this competition in Waterbury have been the health insurance companies who have driven reimbursement rates in Waterbury to very low levels. These savings have not been passed along to consumers, but only used to increase the insurers' corporate profits and their executives' salaries. Neither hospital in town has had sufficient capital to make improvements in their facilities, staff, and services and have lost significant numbers of physicians and patients to Danbury, New Haven and Hartford. Other cities of similar size, such as New Haven and Danbury, have been blessed with vigorous and well funded community hospitals which have provided world class services.

The two previous major attempts to rectify the situation in Waterbury both failed; first the merger with St. Mary's and then Waterbury's purchase by Tenet Corporation.

I have had the opportunity to visit the current perspective buyer, Prospect Holdings, in California, interview their staff and leadership and have worked on the new IPA with them. Prospect has extensive experience in managing and funding hospitals such as Waterbury throughout the country and has done a very good job recapitalizing declining

institutions, improving their competitive nature, and providing much better, higher quality services to their communities. Prospect has an enviable record nationwide in managing "value added care" and in creating risk based contracts with cost saving and improved coordination of care for patients.

I have also met with the doctors (both employees and independent) in Rhode Island who work at two Prospect acquired hospitals there. These physicians are very satisfied with the Prospect management and told me that Prospect rescued two failing institutions that are rapidly becoming viable and vigorous community resources.

Consequently, I can unequivocally support the proposed purchase of Waterbury Hospital by Prospect. I believe this is the best possible plan for the Waterbury community, current and future patients and the physicians.

I fear that this may be Waterbury Hospital's last chance. If this transaction is not completed, I wonder if the institution can remain viable. I urge you to decide in favor of the transaction.

As a past Board Member and past Chairman of Waterbury Hospital and the Greater Waterbury Health Network, I am acutely aware of the financial fragility of the hospital system in Waterbury. Waterbury Hospital has been able to maintain a high quality of health care in the absence of needed capital expenditures by virtue of the hard work and dedication of its staff. However, in my view it is questionable how much longer the high quality of health care currently provided by the hospital can be maintained without significant capital investment.

The pace of technical development in the health care industry requires investment in new technology in the form of equipment and the hiring of physicians to bring the next generation of health care to the hospital. In addition, existing equipment and facilities require upgrading in order to adequately meet current and future demand for health care. Without these investments, the quality of care and scope of services will gradually be eroded until we have a second rate health care system in Waterbury.

Given the high percentage of Waterbury Hospital's revenue coming from Medicaid and Medicare, there is insufficient surplus available to fund these necessary investments. That is why the acquisition of the Greater Waterbury health Network and Waterbury Hospital by Prospect Medical Holdings is so crucial to the future of health care in Waterbury. A company like Prospect has the capability to tap the capital markets to provide funding for these essential investments in the future.

As an argument for maintaining the status quo, some have claimed that a for-profit hospital can only survive by curtailing services and compromising quality. Ironically, that is precisely what will eventually happen if we do maintain the status quo.

Suggesting that a profit-seeking enterprise that is intent on growing its business would proceed in such a manner is ludicrous. Why would an organization seeking to grow in volume and revenue embark on a path of alienating its customers and reducing the services it offers? To the contrary, it would be incentivized to delight its customers, both patients and doctors, by providing expanded, high quality services so that they would be motivated to use the hospital and recommend it to others.

My name is Brian Emerick and I am the President for Access Rehab Centers, which is a local rehabilitation company that is a partnership between Waterbury Hospital and Easter Seals of Greater Waterbury.

I would first like to thank you for the opportunity to share some thoughts regarding the proposed acquisition of Waterbury Hospital by Prospect Medical Holdings.

I would respectfully ask that, when considering this transaction that we need to take into consideration, not just the history of Waterbury Hospital or even what the current state of healthcare is in this community ... I would suggest that we need to consider where we are going in the "big picture" for healthcare and what that means for the survival of all healthcare facilities going forward.

There are big changes in healthcare that are going on right now. Those changes will lead to major challenges to the survival of hospitals, independent practices, and many of the traditional institutions that we have all taken for granted as being our traditional healthcare system.

Everyone knows that Hospitals are struggling under reduced reimbursements as well as a significantly larger number of people who require services.

There are several major trends that are impacting almost all of the Hospitals in CT...one of the most significant is that healthcare is moving more towards preventing sickness and maintaining health. One of the key changes to make that happen is treating people in their home or in the least costly location. That means that the definition of "success" for a Hospital is changing from providing the best care possible to as many people as possible..to a point in the future where the definition of success will be "supporting health for all people in the community, preventing sickness and preventing the need for hospitalizations". There is one serious flaw in the process for the average Hospital; when a hospital does not have the community based resources available to create that healthier community then they will not be able to achieve the results that they will be expected to achieve and as reimbursements continue to go down for hospitalizations, those hospitals that cannot provide a more robust outpatient network will eventually be forced to close. In the future, Hospitals will be paid to keep people healthy and each hospital will be expected to absorb more and more of the costs for individuals who eventually do require hospitalizations.

I have worked with Waterbury Hospital for over 16 years and I can honestly say that the care at Waterbury Hospital today is the best that I have ever seen it be in those 16 years. It is of a higher quality and it is provided with a significantly higher degree of efficiency as well. Even with all of those positive changes I can say that the expectations that are on a Hospital today make it extremely hard to provide care and keep the doors open. How many of the business owners in a community could stay open if

there were an increasing number of people walking through their doors that were only required to pay below cost for the goods that they purchase? This is an easy equation.....if more people pay below costs for your goods or services, you have to make up the difference on the other customers that walk through the door or your will be out of business. You either increase your prices (which Hospitals are no longer able to effectively accomplish) or you decrease your costs. CT Hospitals can only go through so many rounds of layoffs before they run out of options. We have already seen all of the area Hospitals do many rounds of layoffs and I would say that many CT Hospitals will continue to have to make those same tough choices.

So why Prospect? As I see it, there are two primary reasons: the first is that Prospect brings to the table the expertise and the connections to assist in reducing expenses even further. By bringing in large purchasing agreements to reduce supply costs and by bringing additional ideas for new ways to do best practices and reduce inefficiencies and redundancies....ideally we can streamline the system without having to cut into staffing and quality.

The second reason is the biggest reason of all: Prospect brings the capital that Waterbury Hospital will require to adapt itself to the new demands of Healthcare and be able to survive. I would anticipate that, with adequate funds, Waterbury Hospital will continue to develop services integrated into the surrounding communities so that healthcare is available in a much more efficient and easily accessible manner so that folks in the community will be able to access health care quicker, maintain their health and prevent costly hospitalizations.

I have looked at the Prospect system and it is obvious that they know what they are doing. They know how to decrease costs and run efficient Hospitals. That means that not only do their Hospitals provide the healthcare and the jobs that the community needs but they also have the capital to be able to adapt and grow rather than just reel from one fiscal challenge to the next.
