## RIDGEFIELD YOUTH WINS LAW DAY ESSAY CONTEST

HARTFORD -- Attorney General George Jepsen today congratulated William Baughman, 14, of Scotts Ridge Middle School in Ridgefield, for taking first place in the 18<sup>th</sup> annual Law Day essay contest sponsored by the Office of the Attorney General.

"Should students be suspended or expelled for comments or threats they make towards a teacher or school on Facebook?" was the topic that drew 546 entries from 8<sup>th</sup> grade students from around the state. A panel of 14 judges selected the top five essays and recognized five more with an honorable mention.

William Baughman concluded that students should be expelled. "When we evaluate the First Amendment, we must make the assumption that the freedom of speech was meant to preserve our rights to voice opinions, feelings and emotions and not to be corrupted into a shield to hide behind for those making threats and proposing violence," he wrote.

Jepsen will present a certificate to the winner in a May 19 assembly at his school.

"I commend all the students who participated in this year's contest. Excellent essays were contributed and our judges spent many hours reading the entries and evaluating the students' arguments before making their choices," Jepsen said. Jepsen also praised the students' teachers who encouraged their students and worked with them to participate.

Other winning essays were: second, Nick Fiore of Cloonan Middle School, Stamford; third, Rebecca Goldman, Kingswood Oxford, West Hartford; fourth, Lauren Freedman, Cheshire Academy; and fifth, Shawn Murdzek, East Hartford Middle School.
