Dear Congressional Leaders,

Gun violence is a public safety and public health crisis in the United States, affecting all of our communities. As the Attorneys General of our respective states, we are asking for your help in preventing further gun violence by supporting Jaime's Law (H.R. 1705, S. 1924) to require background checks for ammunition purchases, building on current federal requirements for background checks on firearms purchases.

Over the past several weeks, America has been subjected to a rash of mass shootings, among them:

 Odessa, Texas – 7 people were killed and another 22 injured during a shooting spree following a routine traffic stop; Congressional Leaders September 23, 2019 Page Two

- Mobile, Alabama 10 youth between the ages of 15 and 18 were wounded in a shooting at a high school football game;
- Philadelphia, Pennsylvania 6 police officers were wounded by a single gunman in an hours-long standoff;
- Dayton, Ohio 9 people were killed and 27 wounded on a crowded street by a gunman with an AR-15-style assault rifle; and
- El Paso, Texas 22 were killed and 26 injured in a race-motivated shooting at a Wal-Mart.

While mass shootings garner the most media attention, they represent only a fraction of the American lives lost to guns and gun violence. Over 14,000 Americans are killed with firearms every year. Another 100,000 are injured. And 23,000 more commit suicide using guns. This everyday gun violence impacts American communities and families in urban, rural, and suburban areas.

As Attorneys General, each of us swore an oath to uphold the Constitution and the rights of law-abiding citizens to possess firearms. But we take seriously our responsibility to do our part to stop gun violence in our communities, and we need additional tools to do our jobs more effectively and better protect the people we serve. Existing federal law has too many loopholes that can be exploited by individuals who are prohibited from owning firearms. We must close these loopholes, starting with ammunition sales.

Jaime's Law is named after Jaime Guttenberg, who was 14 years old when she was one of 17 students and teachers killed in a mass shooting at her school in Parkland, Florida. This bill would make it illegal for individuals who are already "prohibited purchasers" under federal law—including convicted felons, domestic abusers, and individuals with serious mental health conditions—from purchasing or possessing ammunition. To enforce this requirement, individuals would either have to be licensed to own a firearm or undergo a background check to purchase ammunition. Federal law already places these requirements on firearms sales; we believe that extending those same requirements to ammunition will reduce gun violence and suicide, making our communities safer.

There is no reason for a convicted felon or anyone else who is not legally permitted to purchase a firearm to be able to purchase ammunition. Importantly, Jaime's Law adds these protections without infringing on law-abiding citizens' rights to own firearms, nor on states' rights to regulate firearms as they see fit.

We applaud the sponsors and cosponsors of Jaime's Law and thank them for their leadership. We are pleased to hear that this bill will be considered by the House Judiciary Committee this fall. We ask that committee to give this bill due consideration, and we urge the House and the Senate to ensure this important bill is passed so that we in law enforcement can stop individuals who are prohibited from possessing a gun from also obtaining ammunition.
