Governor Dannel P. Malloy signed the following legislation of the 2018 Regular Session on May 31:

SB 455 PA 18-34	AN ACT CONCERNING MINORITY TEACHER RECRUITMENT AND RETENTION. This bill has various effective dates.
SB 142 PA 18-36	AN ACT CONCERNING ACCEPTANCE OF INSTITUTIONAL ACCREDITATION OF PRIVATE OCCUPATIONAL SCHOOLS BY THE OFFICE OF HIGHER EDUCATION. This bill takes effective July 1, 2018.
SB 194 PA 18-40	AN ACT CONCERNING DEPARTMENT OF CONSUMER PROTECTION LICENSE STREAMLINING. This bill has various effective dates.
HB 5384 PA 18-41	AN ACT CONCERNING PRESCRIPTION DRUG COSTS. This bill takes effect January 1, 2020.
HB 5574 PA 18-42	AN ACT CONCERNING THE FAILURE TO FILE FOR CERTAIN GRAND LIST EXEMPTIONS, VALIDATING A CONNECTICUT GREEN BANK AGREEMENT AND CERTAIN ACTIONS OF THE CITY OF DERBY, CONCERNING PAYMENT OF A GRANT-IN-AID TO THE TOWN OF DARIEN AND THE CRITERIA OF CERTAIN MEMBERS OF SCHOOL GOVERNANCE COUNCILS AND EXTENDING A PROVISION CONCERNING REEMPLOYMENT OF CERTAIN TEACHERS. SB 11 PA 18-49	AN ACT CONCERNING AN AFFECTED BUSINESS ENTITY TAX, VARIOUS PROVISIONS RELATED TO CERTAIN BUSINESS DEDUCTIONS, THE ESTATE AND GIFT TAX IMPOSITION THRESHOLDS, THE TAX TREATMENT OF CERTAIN WAGES AND INCOME AND A STUDY TO IDENTIFY BEST PRACTICES FOR MARKETING THE BENEFITS OF QUALIFIED OPPORTUNITY ZONES. This bill has various effective dates.
SB 184 PA 18-138	AN ACT CONCERNING AUTHORIZATION OF STATE GRANT COMMITMENTS FOR SCHOOL BUILDING PROJECTS AND CHANGES TO THE STATUTES CONCERNING SCHOOL BUILDING PROJECTS. This bill has various effective dates.
