In the fall of 1912 Mr. M. A. Carleton of the Commission for the Investigation & Control of Chestnut Blight Disease in Pennsylvania forwarded to our Greenwood Nursery a few pounds of Chinese chestnuts received from China thru the U.S. Dept. of Agriculture. These nuts were planted in the nursery in the spring of 1913 and 50 seedlings were produced. In 1916 these seedlings were planted near Greenwood Furnace, unfortunately, the majority were planted at a place subject to late frosts. As a result they have been frozen back every year. We have probably eight or ten that are still living. Two were planted about three miles from Greenwood Furnace, they are now about eight to ten feet high and have been bearing nuts during the last three or four years.

The blight has killed all of the native chestnut trees in this vicinity, the Chinese chestnut has been quite resistant to the blight, no trace of it can be found on any of the trees.
