Governor Dannel P. Malloy signed the following legislation of the 2017 Regular Session on June 13:

SB 912 PA 17-41	AN ACT CONCERNING REVISIONS TO THE STAFF QUALIFICATIONS REQUIREMENT FOR EARLY CHILDHOOD EDUCATORS. This bill takes effect on July 1, 2017.
SB 1026 PA 17-42	AN ACT CONCERNING REVISIONS TO THE HIGH SCHOOL GRADUATION REQUIREMENTS. This bill takes effect on July 1, 2017.
HB 5452 PA 17-43	AN ACT CONCERNING THE PRACTICAL TRAINING AND EXPERIENCE OF STUDENT EMBALMERS. This bill takes effect on October 1, 2017.
HB 6979 PA 17-44	AN ACT CONCERNING THE ACCREDITATION OF DENTAL ASSISTANT PROGRAMS. This bill takes effect from passage.
HB 7106 PA 17-45	AN ACT CONCERNING AUDIT REPORTS FILED WITH THE PUBLIC UTILITIES REGULATORY AUTHORITY. This bill takes effect from passage.
HB 7173 PA 17-46	AN ACT CONCERNING THE APPOINTMENT OF ASSISTANT REGISTRARS OF VITAL STATISTICS. This bill takes effect on October 1, 2017.
HB 7196 PA 17-47	AN ACT CONCERNING NONADVERSARIAL DISSOLUTION OF MARRIAGE. This bill takes effect on October 1, 2017.

HB 7245 PA 17-48	AN ACT CONCERNING THE REVISOR'S TECHNICAL CORRECTIONS TO THE GENERAL STATUTES. This bill takes effect on October 1, 2017.
HB 7250 PA 17-49	AN ACT CONCERNING DESECRATION OF AN ABANDONED CEMETERY. This bill takes effect on October 1, 2017. **While Governor Malloy signed this bill, he wrote a letter to the members of the General Assembly regarding its content. Scroll down to view that letter.
SB 1021 PA 17-50	AN ACT REVISING THE UNIFORM FRAUDULENT TRANSFER ACT. This bill takes effect on October 1, 2017.
SB 1059 PA 17-51	AN ACT CONCERNING DEFICIT MITIGATION FOR THE FISCAL YEAR ENDING JUNE 30, 2017. This bill takes effect from passage.
SB 975 PA 17-52	AN ACT CONCERNING MUNICIPALITIES AND UNMANNED AIRCRAFT. This bill takes effect from passage.
SB 867 PA 17-53	AN ACT CONCERNING NOTICE REQUIREMENTS FOR HOME HEALTH CARE REGISTRIES. This bill takes effect on October 1, 2017.
HB 7323 SA 17-3	AN ACT MAKING DEFICIENCY APPROPRIATIONS FOR THE FISCAL YEAR ENDING JUNE 30, 2017. This bill takes effect from passage.
SB 817 SA 17-4	AN ACT CONCERNING THE CLAIMS AGAINST THE STATE OF JOANNE AVOLETTA, PETER AVOLETTA AND MATTHEW AVOLETTA. This bill takes effect from passage.
SB 945 SA 17-5	AN ACT CONCERNING THE SOUTH CENTRAL CONNECTICUT REGIONAL WATER AUTHORITY. This bill takes effect from passage.

As of this date, the Governor has signed sixty (60) bills of the 2017 Legislative Session.
