

# Working Together to Build a Stronger Community

**B**aptism by fire is the way Andres Ayala, Jr. describes his first two months on the job as Commissioner of the Department of Motor Vehicles (DMV). A major water main break flooded the Wethersfield DMV's electric room, wiping out the building's electrical system. Ayala gave full credit to his team of experts at the DMV for getting

the power restored with the help of four generators and with only one day's interruption of service.



Even though his first two months as commissioner were a harrowing experience, the cup is always half full in Ayala's eyes. It is this positive outlook on life and a strong determination to help his community that drives this lifelong Connecticut native. Andres Ayala, Jr. was born and raised in Bridgeport, CT. After earning an Associate's Degree in Paralegal Studies, Ayala attended Sacred Heart University. He earned a Bachelor of Science degree in Business Administration and went on to earn a Master's degree in Education. After teaching

for twenty one years as a social studies teacher and working in adult education, Ayala made the switch to the political arena.

Growing up, Ayala was instilled with the practice of giving back to the community and helping others in need. Ayala's family was always involved in local politics, so the transition was an easy one. Ayala began his political career serving on several committees in the Bridgeport City Council. He rose through the ranks to become the first Latino president of the Bridgeport City Council. While serving on the Council, Ayala supported the development of Steelpointe Harbor, a 2.8 million square-foot mixed-use, urban-oriented waterfront complex in Fairfield County. Located on prime real estate, plans include new retail and restaurant establishments, 2200 units

of housing, and a hotel and conference center.

Ayala went on to serve three terms for the Connecticut House of Representatives for the 128th district from 2006 to 2012, where he held the position of Vice Chair of the Finance, Revenue and Bonding Committee. It was while serving in the House that he realized the impact of

## **CISS Project Management Updates**

### Gearing Up for Search and Workflow Releases

Release 1 and Release 2. The CJIS Project Management team and Xerox completed the requirements and design for Release 1 - Paperless Re-Arrest Warrant Network (PRAWN) and Offender Based Information System (OBIS). CJIS and Xerox also finalized the requirements for Release 2 - Uniform Arrest Report (UAR) and Misdemeanor Summons Arrest Notices, and began the Design phase.

The Xerox and CJIS teams will confirm the technical documentation and functioning of PRAWN and OBIS replicas for Release 1 in preparation for the Design phase.

Working with Judicial, the CJIS
Technical team began work
on federal authentication. This
provides a single sign on so that Judicial
users can access the CJIS SharePoint site with
their credentials.

The Project Management team reset the baseline for the SharePoint Project Tracking Tool for each agency. The CJIS Technical team launched the new SharePoint

sites that include the SharePoint Project Tracking Tool for Judicial and the Department of Corrections. This will enable each agency to track and adjust their resources for the CISS project and to view project documents, tasks and the project timeline.

Information Exchange Document Security Focus Group Sessions will begin in mid-April and will continue into May. Concerns about security in the CISS system will be addressed.

Meanwhile, the CJIS Technology team began work on the CISS Development Environment for Xerox. Efforts will continue in April with the addition of an enterprise service bus. An enterprise service bus (ESB) is a software architecture model used for designing and implementing communication between mutually interacting software applications in a service-oriented architecture (SOA). The CJIS Technical team will

also be adding a master data management tool (MDM). A MDM tool removes duplicates, standardizes data (mass maintaining), and incorporates rules to eliminate incorrect data from entering the system in order to create an authoritative source of master data.

## **RMS Network Update**

Plans are underway to draft the first RMS vendor contract with the Capitol Region Council of Governments (CRCOG) for RMS Certification with CT:CHIEF RMS. CT:CHIEF RMS is a browser-based records management system that organizes, stores, and transmits secure law enforcement and public safety information. Once certified with CT:CHIEF RMS, a local law enforcement agency will automatically be in a position to obtain access to CISS.

Seventy-six police departments have purchased routers for

the CISS project. Of the seventy-six departments, fifty-five departments are connected to the state network with initial connectivity. CJIS and DAS/BEST are continuing to schedule router connections with the remaining police departments as part of Phase 2 operations.

As local police departments are connected, CJIS will update the interactive county and state maps and add them to agency SharePoint sites. •

## **OBTS Interruption of Service**

There will be a temporary interruption of service of OBTS to facilitate the migration from the Oracle to the SQL database environment. The *tentative* time frame of the outage is from April 2, 2015 through April 9, 2015.

CJIS will be sending out an email to all known users just before the interruption and will also send notices once the migration is complete and OBTS is back in service.
