## ~ SMILES2GO: Saint Raphael's Mobile Dental Clinic ~

Saint Raphael's Hospital operates a dental van called Smiles2Go in the New Haven area. Smiles2Go is not really a van, but a 65 foot trailer that houses a complete dental clinic. This clinic on wheels is staffed by a dental hygienist who provides preventative services. The van features two treatment rooms, a sterilization room, a waiting area and a wheelchair lift.



The van travels the neighborhoods in the New Haven area to help adults and children access affordable preventative dental services. This summer the dental van will visit several locations. One of the first locations will be in front of Stetson Library,

on 197 Dixwell Avenue in New Haven. The van will be there on Tuesdays from 9:00 – 1:30. On Thursdays the van will be providing services in front of the Lifehaven building on 447 Ferry Street in New Haven from 9:00 – 1:30.

### Rescinding of Dental Waivers

In recent years several individuals who reside in a CTH and do not have teeth have been granted a dental waiver allowing their physicians to perform an oral exam. After having discussions with numerous dental professionals it was concluded that although it is perfectly legal for the physician to do an oral exam, it is not best practice. Dentists routinely do oral exams and are more in tune to subtle changes in the oral cavity and surrounding tissues. It is recommended that a licensed dentist complete an oral exam once a year on an individual with no teeth or dentures.
