The Connecticut Department of Energy and Environmental Protection (DEEP) is proposing a revision to the Connecticut State Implementation Plan (SIP) by requesting the following obsolete single source volatile organic compound (VOC) Reasonably Available Control Technology (RACT) orders be removed from the SIP:

Order #8010, Addenda A and B issued to Sikorsky Aircraft Corporation,

Order #8011 issued to Dow Chemical Company,

Order #8014 issued to Pratt & Whitney Aircraft.

Order #8010 was closed on August 26, 2004. Order #8011 and Order #8014 were closed on May 26, 2016. Copies of the orders and the closure documents are included as Attachment A through C. As demonstrated in the closure documents, this SIP revision will have no impact on VOC emissions. DEEP has the necessary legal authority to issue and close consent orders under §22a-6 and §22a-174 of Connecticut General Statute.

DEEP satisfied the public participation requirements during the SIP revision process in accordance with 40 CFR 51.102. To demonstrate satisfaction of the federal public participation requirements, we have enclosed the public notice as Attachment D and a certification of public participation as Attachment E. The public hearing was canceled because no one requested a hearing by April 26, 2016, the deadline for requesting a hearing as announced in the hearing notice, and no comments were received.
