Re: Connecticut State Implementation Plan for Clean Air Act Section 110(a) Infrastructure Elements: 2012 PM_{2.5} NAAOS

Dear Mr. Conroy:

Pursuant to section 110(a)(1) and (2) of the Clean Air Act (CAA), states are required to submit any necessary revisions to their State Implementation Plans (SIPs) to provide for the implementation, maintenance and enforcement of any revised or new national ambient air quality standard (NAAQS). Such revisions are commonly referred to as "infrastructure SIPs."

Enclosed is the State of Connecticut's infrastructure SIP for the 2012 Fine Particle (PM_{2.5}) NAAQS. This submission includes five revisions to either add a section of the Connecticut General Statutes (CGS) or to add revisions to certain sections of the Regulations of Connecticut State Agencies (RCSA) to ensure Connecticut's SIP contains adequate infrastructure elements for the protection of public health with respect to the 2012 PM_{2.5} NAAQS. This submission also includes the necessary documentation to satisfy the public participation requirements of 40 CFR 51, Appendix V, Section 2.1. The structure of this submission is as follows:

- Enclosure A: Final SIP technical support document (TSD) demonstrating Connecticut's adequacy with regards to the infrastructure elements for the 2012 PM_{2.5} NAAQS. The TSD describes and refers to the following Attachments containing necessary CGS and RCSA revisions, as well as a required technical analysis.
