COMPREHENSIVE ENERGY STRATEGY

NOTICE OF REQUEST FOR WRITTEN COMMENTS AND NOTICE OF TECHNICAL MEETINGS AND PUBLIC HEARINGS

Pursuant to Section 51 of Public Act 11-80, An Act Concerning the Establishment of the Department of Energy and Environmental Protection and Planning for Connecticut's Energy Future, and Section 22a-6 of the General Statutes of Connecticut, the Commissioner of Energy and Environmental Protection ("the Commissioner") hereby provides notice of his intent to adopt a Comprehensive Energy Plan or a Comprehensive Energy Strategy ("Strategy"). The draft Strategy will assess and provide a blueprint for Connecticut's energy needs. The major topics to be reviewed in the draft Strategy are Transportation, Energy Efficiency (Buildings and Industry), Electricity, and Cross-cutting Issues (e.g. Natural Gas). The draft Strategy will provide long term guidance on how to meet the goals of multiple State plans including: the Integrated Resources Plan, the Conservation and Load Management Plan, the Climate Change Action Plan and the Clean Energy Finance and Investment Authority's Comprehensive Plan. The draft Strategy will also contain recommended actions aimed at providing near-term benefits and establishing a foundation upon which to build a sustainable energy future in Connecticut. Preparation of the draft Strategy has included a broad spectrum of stakeholders.

<u>Public Hearings:</u> While the Strategy proceeding is not a contested case, the Department is required to hold a hearing on the draft Strategy pursuant to Chapter 54 of Connecticut General Statutes. Given the breadth of the issues contained in the draft Strategy the Department will be

holding a series of public hearings in different locations around the state to encourage broad public participation. These hearings will satisfy the statutory public hearing requirement. The purpose of the Public Hearings is to provide the public with an opportunity to provide comments on the draft Strategy.
