Item 1. – Project Narrative

1. Identify project Goals and Objectives

The Town of New Milford is requesting consideration for funding from the Housatonic River Natural Resources Restoration Project for the development of Sega Meadows Park. Sega Meadows Park was purchased by the Town of New Milford in 1992 and has yet to be developed. Sega Meadows is a 23-acre public park nestled between the beautiful Housatonic River and scenic River Road in northern New Milford.

Prior to 2005, the Town was unable to fully use this undeveloped park area due to public fear of PCB contamination, limited pedestrian access and no available parking for vehicles. However, in November 2005, through the generosity of Northeast Utilities, an additional 65.12 acres on the Housatonic River was licensed to the Town to be used expressly for access improvements and development of the park. The Town of New Milford would like to begin the process of appropriately utilizing this wonderful resource for passive recreational use.

2. Project Benefits

The proposed improvements will provide numerous benefits, including, but not limited to the following:

- Provide the public with unique educational opportunities and direct public access to this
 pristine property through the creation of a parking area, installation of signage and an
 information kiosk
- Continued support for a variety of wildlife, including bobcats, wild turkeys, foxes, coyotes, beavers, deer, a wide variety of fish and numerous types of birds for the naturalist to enjoy
- Creation of nature trails throughout the park and alongside the river, including identification of native flora and fauna through the use of educational signage
- Establishment of picnic areas, and areas for primitive camping
- Creation of designated areas for fishing, non-motorized boating and the establishment of trails for mountain biking, horseback riding and cross country skiing.
- Promotion of programs emphasizing the importance of wetlands awareness and the preservation of the Housatonic River habitat and tiered floodplain system.
- Provide opportunities for schools, scouts and emergency preparedness personnel to visit and study floodplain function and formation



3. General Tasks

The general tasks in order to bring this project to fruition are the following:

- Procure the appropriate permits as required by federal, state and local agencies
- Purchase and installation of appropriate erosion controls
- Purchase and installation of materials necessary for construction of the access road and parking area
- Purchase and installation of site amenities, including picnic tables, grills, park benches, garbage receptacles, and bike rack
- Purchase and installation of park signage
- Design and development of the trail system and an information kiosk
- Development and construction of a primitive camping area on the banks of the Housatonic River
- Development of a designated fishing area along the Housatonic River and around a pond located on the property
- Maintenance and development of a nature observation area around the pond and along the river bank
- Purchase and installation of nesting boxes for native species of birds

We are confident that this project meets your criteria and believe this proposal would be of interest to the Housatonic River Natural Resources Restoration Project Sub-Council. Through careful planning, the passive and active recreational areas proposed for this property will encourage the public to improve and preserve the environmental conditions along the shoreline of the Housatonic River.
