Recycling and Reuse Opportunities

Wire Hangers: The environmentally preferable management of hangers is to reuse them a number of times before recycling them as scrap metal. Provide container for customers to drop off wire hangers for reuse and recycling.

Plastic Film: Work with your supplier to set up a recycling system for plastic film that includes a container for customers to drop off their plastic film when they drop off their clothes.
