Special Topic: "Save Money and Reduce Trash (SMART)"

Kristen Brown, President – Waste Solutions

The presentation will describe how several Bridgeport area/Southwest Connecticut towns are considering integrating the SMART approach which motivates citizens to produce less trash. Ms Brown has been helping communities take a comprehensive look at just how much they are truly spending on solid waste disposal. In addition to the potential cost savings (by utilizing a unit based approach) to municipalities, there are also potentially significant environmental benefits with the resulting decrease in the amount of waste being disposed and the increase in amount of material being recycled. Of greatest benefit is the anticipated reduction in the amount of green house gas emissions that will result as we reduce the amount of waste we put into landfills and/or waste-to-energy facilities (thereby reducing the amount of methane and carbon dioxide emitted) and the emissions associated with producing products using virgin materials.

Special Topic: "Preliminary Results/Overview of the Statewide Recycling Survey"
 Diane Duva, CTDEP Assistant Director – Solid and Hazardous Waste Programs

In 2008, the CTDEP surveyed municipalities to understand how they manage and account for municipal solid waste. To date, approximately 85% of the Connecticut's municipalities have responded. The results from the survey provides a baseline of the state's materials management landscape and will be used to create guidance for municipalities targeting specific needs based on their current practices. The presentation will provide an overview of the results.
