- **Presentation: Solid Waste Management Permit Program Review Process**

**Background:** Recently enacted **Public Act 10-158 – An Act Concerning the Permit and Regulatory Authority** requires the DEP to conduct an analysis of its 25 regulatory permit programs. This analysis is to identify process improvements, additional resources, staffing and programmatic changes necessary to improve upon timeframes for permit decisions, while maintaining the State’s environmental standards. As part of this process, public informational meetings are to be held. DEP is to prepare and submit a comprehensive report to the Governor and the General Assembly by September 30, 2010. For this Advisory Committee Meeting, the products and processes of CTDEP’s Solid Waste Management Permitting will be covered and the attendees will be asked to share their input and concerns.
