Participant Updates	The report on programs used by police departments to refer people with substance use problems to treatment was presented at the last ADPC meeting. It is being distributed with the intent to be a resource for those interested in starting a police diversion program. It will be presented at the Law Enforcement Conference on April 5th.  CT participated in the 1st national meeting on police referral to treatment programs.  Hartford and New Haven police departments continue their work on implementing LEAD.  Dr. Maurer is being honored by the American Association for the Treatment of Opioid Dependence and received the Nyswander/Dole award for her outstanding work in expanding methadone in corrections.  The Early Screening and Intervention pilot program is expanding to New London, Norwich, New Haven, and Hartford courts. They should be starting in April. The Bridgeport and Waterbury sites have been running for almost a year. A report by the states attorney's office on the program is due as required by the legislation by 2/1/19.  The US attorney's office will present on 3/23/18 at the CT Association of Schools to athletic directors and coaches on prevention of opioids in particular as it connects to sports injuries. They have done 90-100 high school presentations so far.  Recovery coaches are now available in 9 hospitals throughout CT. Danbury Hospital and St. Francis Hospital have started suboxone inductions.
