Introduction

The Evaluation, Quality Management and Improvement (EQMI) Division at the Department of Mental Health and Addiction Services (DMHAS) is pleased to publish the inaugural Annual Statistical Report. The report provides information about the services the Department provides and the individuals that are being served within our mental health and substance abuse system. This first report encompasses two fiscal years of statistical data. It is expected that future reports will be distributed annually, typically in October and will cover a single fiscal year

The data presented in the report were taken from DMHAS' Enterprise Data Warehouse on July 22, 2014 for SFY 13 and on August 27, 2014 for SFY 14. It reflects services that were provided by DMHAS funded or operated agencies. The data warehouse is a dynamic system so reports or other analyses performed at different times may produce slightly different results. In the future, EQMI will download and analyze DMHAS data in mid to late August, in order to provide a consistent snapshot of services provided in a given fiscal year.

The report was developed in response to numerous requests that EQMI receives throughout the year about our service system. EQMI receives multiple requests for data from DMHAS staff, providers, legislative groups, researchers and the media. It is intended to make the information more accessible to departmental stakeholders. The report includes data on clients served, demographic characteristics, types of services provided, residential and inpatient utilization, and substance use trends. The report will likely evolve as new data requests emerge.

A number of staff from EQMI and contractors from the University Of Connecticut School of Social Work were involved in the development of the report. Karin Haberlin coordinated the development of the report while Kristen Miller, Hsiuju Lin, and Hiroki Toi compiled, tested, and analyzed the data. Kristen Miller was responsible for writing the report. Susan Wolfe began piloting the report last year, helping to outline essential data components and the general report format. Special thanks to all of the EQMI staff that participated on this project.

Background

In this report, the Department of Mental Health and Addiction Services (DMHAS) has compiled data to summarize the clients served and services provided during the 2013 and 2014 fiscal years. The data includes clients served in DMHAS funded or DMHAS operated programs. The clients and the services are diverse and the data is complex.

This report will, at different times, report numbers that refer to different subgroups or events that are based on specific filtering of the data. For instance, we filter out programs that are not required to report treatment data when we present the data from the perspective of Level of Care.

We also distinguish between clients and episodes:

- **Client counts** are unduplicated counts in which each client is counted **once**.
- **Episode counts** represent an episode of care to a client –admission, services received, and discharge all occur within the context of an episode of care for a client at a particular program.
- Each client may have multiple episodes of care that occur within the fiscal year, thus the client will be counted **multiple times** – once for each episode.
- **Admissions and Discharges** are reported as **episode counts**.
- A client may be admitted to several programs, and *each* admission will be included in the overall Admission count below.

In each section of the report, there is a brief description of what the counts represent.

The data contained in this report were taken from DMHAS' Enterprise Data Warehouse (EDW) on July 22, 2014 for SFY13 and on August 27, 2014 for SFY14. The data warehouse is a dynamic system, so reports or other analyses performed on different dates may produce slightly different results. The numbers contained in this report are the official DMHAS data for SFY2013 and SFY2014.

Data Summaries

SFY2013 - CLIENTS, ADMISSIONS AND DISCHARGES

- During State Fiscal Year 2013 (July 1, 2012 – June 30, 2013), the Department of Mental Health and Addiction Services served **106,559** people.
- **57,704** clients were treated in **Substance Abuse (SA)** programs (50,090 in only SA programs, plus 7,614 who received SA and MH services).
- **56,469** clients (were served in **Mental Health (MH)** programs. 48,855 MH only, plus 7,614 MH and SA)
- A smaller group of clients (**7,614**) received services from **both MH and SA** programs during SFY13.¹
- There were **111,397 admissions** (each client may have a single or multiple admissions) to DMHAS operated or DMHAS funded programs.
- **69%** of clients had a **single MH program admission**.
- **71%** of clients had a **single SA program admission**.
- There were more admissions to Substance Abuse programs than to Mental Health programs.

¹ Note that receiving services from both program types does not imply that these clients have a dual diagnosis.

During this same timeframe,

- There were **107,155 discharges** from DMHAS operated or DMHAS funded programs. This does not necessarily mean that clients were discharged from the DMHAS system completely, simply that they left a program (possibly for another program).
- Again, there were more discharges from SA programs than from MH programs.
- Finally, there were **43,596** episodes of care (covering **36,182** clients) that were **open for the entire fiscal year** (admitted prior to SFY13 and not yet discharged by the end of SFY13).

SFY2014 - CLIENTS, ADMISSIONS AND DISCHARGES

- During State Fiscal Year 2014 (July 1, 2013 – June 30, 2014), the Department of Mental Health and Addiction Services served **107,963** people.
- **56,782** clients were treated in **Substance Abuse (SA) programs**. (49,552 in only SA programs plus 7,230 who received SA and MH services)
- **58,384** clients were served in **Mental Health (MH) programs**. (51,154 MH only plus 7,230 MH and SA)
- A smaller group of clients (**7,230**) received services from **both MH and SA programs** during SFY14.²
- There were **105,016 admissions** (each client may have a single or multiple admissions) to DMHAS operated or DMHAS funded programs.
- **66%** of clients had a **single MH program admission**.
- **70%** of clients had a **single SA program admission**.
- As in SFY13, there were more admissions to Substance Abuse programs than to Mental Health programs.

During SFY14:

- There were **101,101 discharges** from DMHAS operated or DMHAS funded programs. This does not necessarily mean that clients were discharged from the DMHAS system completely, simply that they left a program (possibly for another program).
- There were more discharges from SA programs than from MH programs.
- There were **47,625** episodes of care (covering **39,143** clients) that were **open for the entire fiscal year** (admitted prior to SFY14 and not yet discharged by the end of SFY14).

DEMOGRAPHICS OF CLIENTS SERVED

The data presented in the Demographics section includes all clients served by DMHAS. The values represent unduplicated client counts (each client counted once) within program type (SA only, MH only or both SA & MH). The statewide total is a fully unduplicated client count. The narrative will generally discuss the results in terms of SA and MH programs; the counts under the “Both” category will be added into the SA and MH counts to include *everyone* who received SA services or MH services.

Statewide, there were more males who received DMHAS services than females. Within MH programs, approximately equal numbers of men and women received treatment (27,463 (49%) and 28,982 (51%) respectively). In SA programs, however, there were more male clients than female clients (40,040 (69%) and 17,501 (30%) respectively). This pattern across program type was also observed in SFY12.

Of the total number of statewide clients served in FY 2013, 64% were White/Caucasian. With the addition of the next two largest groups, Black/African Americans and Other (often selected by clients of Hispanic ethnicity who view their race as neither Caucasian nor African American), at 16% and 15% respectively, this accounted for 95% of clients served. The distribution of clients by race was very consistent across SA and MH treatment programs. White/Caucasian clients were the most represented in treatment followed by Black/African American and Other at nearly equivalent levels.

Of the total number of clients served by DMHAS, twenty percent were of Hispanic/Latino ethnicity. The largest group of Hispanic/Latino consumers was of Puerto Rican origin (11%). Statewide, 73% of clients receiving DMHAS services were not of Hispanic/Latino ethnicity. The distribution of ethnic origin across SA/MH programs was generally balanced with slightly more consumers (+1%) of Hispanic/Latino origin being treated in Substance Abuse programs. Non-Hispanic clients were more slightly more likely to receive mental health services (+3.5%) than substance abuse services.

Examining the data by age group, it appears that younger clients (up to age 44) were more likely to receive Substance Abuse services while older clients (45 and over) were more likely to receive Mental Health services. Among clients receiving mental health services, the largest age group was 45 to 54 years, while most frequent age group for Substance Abuse clients was the 26 to 34 age range. Of clients receiving treatment, few were 65 years or older with the majority of them in Mental Health services.

respectively). In SA programs, however, there were more male clients than female clients (39,054 (69%) and 17,343 (31%) respectively).

Examining the data by age group, it appears that younger clients (up to age 44) were more likely to receive Substance Abuse services while older clients (45 and over) were more likely to receive Mental Health services. Among clients receiving mental health services, the largest age group was 45 to 54 years, while most frequent age group for Substance Abuse clients was the 26 to 34 age range. Of clients receiving treatment, few were 65 years or older with the majority of them in Mental Health services.

The age demographics of DMHAS clients remained stable across fiscal years 2013 and 2014.

LEVEL OF CARE (LOC) DATA

The data presented in the Level of Care section include clients served by DMHAS funded programs that are required to submit treatment data to DMHAS. The client counts represent unique (unduplicated) clients. The admission and discharge counts are based on episodes of care and represent duplicated client counts – each admission or discharge is counted once, but a client may have multiple admissions and/or discharges. To reduce the chance of confusion between unduplicated client count and admission/discharge counts (they all are counts based on clients), the number of clients admitted or discharged will be referred to as ‘admissions’ or ‘discharges’ (versus ‘clients admitted’). In the SFY13 data below, there were 3,099 admissions to mental health inpatient and residential programs. This represents not the number of unique clients who were admitted, but simply the number of admissions produced by the 4,415 active clients. All tables in this section are expanded to show regional totals in Appendix A (SFY13) and Appendix B (SFY14).

Within the Inpatient and Residential levels of care (LOCs) for MH programs, there were 4,415 active clients in SFY13. The majority (66%) of these clients were in the residential LOC. There were approximately 3,100 admissions to MH inpatient or residential programs and 3,037 discharges during this timeframe.

Within the Outpatient LOC for MH programs, there were 55,549 clients who received services in SFY13. For each LOC listed, the unduplicated client count is provided in the Active Clients table. Within each type of outpatient program, the number of clients represents an unduplicated count. The majority of clients (68%) were served in an outpatient MH program, followed by Crisis (16%), Social Rehabilitation (11%), and Community Support (11%). Clients who received services from more than one LOC are counted in each relevant LOC.

There were 46,695 admissions to MH Outpatient LOCs during the Fiscal Year. The majority of the admissions (62% total) were to outpatient (37%) and crisis services (25%). There were also 42,913 discharges during SFY13. Outpatient and Crisis Services again had the most discharges (64% total) of all the service types.

Within the Outpatient LOC for SA programs (Addiction and Forensic SA), there were 49,209 clients who received services in SFY14. For each LOC listed, the unduplicated client count is provided as well as the total (completely unduplicated) client count. Within each type of outpatient program, the number of clients represents an unduplicated count. Just over a third (34%) of clients were served in Pre-Trial Intervention programs. Equal

percentages of clients (28%) were served in outpatient SA programs and Medication Assisted Treatment. Clients who received services from more than one LOC are counted in each relevant LOC.

There were 34,563 admissions to SA Outpatient LOCs during the Fiscal Year. Approximately 80% of the admissions were to the three LOCs noted above: Outpatient (35%), Pre-Trial Intervention services (29%), and Medication Assisted Treatment (15%). There were also 32,588 discharges during SFY14. Outpatient and Pre-Trial Intervention services again had the most discharges (64% total) of all the service types.

The number of clients in SA Outpatient LOCs remains fairly consistent from SFY13 to SFY14, but there were approximately 2,100 fewer admission and 3,800 fewer discharges in SFY14. The largest differences from year to year are within the Outpatient category: 4,300 fewer clients were served in Outpatient programs in SFY14, 1940 fewer clients were admitted, and 3444 fewer were discharged.

BED CAPACITY AND UTILIZATION

Data for this section comes from the EQMI Outlier Report database (as of September 16, 2014). This data is presented for SFY2014 only. Bed capacity represents the total number of beds available within a Level of Care. Utilization is defined as the number of days each bed is in use during the SFY. State average utilization represents the total number of days each bed is used (# beds * # days used) divided by the total number of bed days (in this case total # beds * 365 days in FY). For Group Homes, there are 173 beds available and they were in use by a client 96% of the time.

Across all active clients in DMHAS funded treatment related programs, alcohol was the most frequently reported primary drug (40%) at admission. The second most frequently reported primary drug was heroin (29%). Marijuana/hashish/ THC was the third most frequently reported drug at 12%; all other drugs were reported as primary at less than 10% of all admissions. Among admissions to SA programs, Heroin (38%) was the most frequently reported primary drug. Alcohol was reported as the primary drug at 33% of admissions. Heroin or other opiate drugs account for the primary drug reported at 45% of all SA admissions. During admission to MH programs, Alcohol was reported as the primary drug for over half of the admissions (54%). The second most frequently reported drug during admission to MH programs was marijuana/hashish/THC (17%).

Overall, alcohol is still the most frequently reported drug at admission. When looking specifically at admissions during SFY13 (table above), the most frequent primary drug reported by clients admitted to SA programs is alcohol (38.7%). Heroin is the second most frequently reported drug (32.8%), although heroin and other opiates together account for an equal number of primary drug reports in SA programs (38.5%) compared to alcohol (38.7%).

Comparing the percentages for heroin and other opiates when looking at all active clients in SA programs in SFY13 versus clients admitted to SA programs in SFY13, there are more active clients reporting heroin and other opiates (45%) than there are new admissions (SFY13 only) (38.5%). This increase is due to the number of clients who stay in long term methadone maintenance programs.

Across all admissions to DMHAS funded treatment related programs, alcohol was the most frequently reported primary drug (37%). The second most frequently reported primary drug was heroin (32%). Marijuana/hashish/THC was the third most frequently reported drug at 12%; all other drugs were reported as primary at less than 6% of all admissions. Among admissions to SA programs, Heroin (42%) was the most frequently reported primary drug. Alcohol was reported as the primary drug at 31% of admissions. Heroin or other opiate drugs account for the primary drug reported at 50% of all SA admissions. During admission to MH programs, Alcohol was reported as the primary drug for over half of the admissions (55%). The second most frequently reported drug during admission to MH programs was marijuana/hashish/THC (18%).

The differences in Primary Drug use reported at admission are relatively small across SFY13 and SFY14. Overall, alcohol was reported as the primary drug at about 2% fewer admissions in SFY14 compared to SFY13, while heroin was reported as the primary drug at almost 3% more admissions in SFY14. Within admissions to MH programs, alcohol as the primary drug was reported at almost 2% fewer admissions in SFY14. During admissions to SA programs, reporting heroin as the primary drug increased just over 4% from SFY13 to SFY14.

Overall, alcohol is still the most frequently reported drug at admission. When looking specifically at admissions during SFY14 (table above), the most frequent primary drug reported by clients admitted to SA programs is almost a tie between heroin (36.7%) and alcohol (36.5%), although heroin plus other opiates together account for 41.5% of reports.

Comparing the percentages for heroin and other opiates when looking at all active clients in SA programs in SFY14 versus clients admitted to SA programs in SFY14, there are more active clients reporting heroin and other opiates (50%) than there are new admissions (SFY14 only) (41.5%). This increase is due to the number of clients who stay in long term methadone maintenance programs.

Overall, the primary drug reported at admission has changed little over SFYs 13 & 14. Alcohol, heroin and marijuana/hashish remain the top three drugs reported for admissions in each fiscal year. Within SA programs the number of admissions reporting heroin increased to tie with alcohol (the top drug in SFY13) for the most frequently reported drug, and, if other opiates are added to heroin, it surpasses alcohol as the most frequently reported drug. The number of new admissions (in the fiscal year only) into SA programs who report heroin or other opiates as the primary drug has risen slightly from SFY13 to SFY14 (38.5% to 41.5%).

DIAGNOSIS

Diagnosis data come from treatment related programs and reflect the most recent primary diagnosis during the most recent episode of care that was open during the fiscal year. These values represent an unduplicated client count within each diagnostic category, however as each client may actually have multiple primary diagnoses on file, the overall percentages do not add up to 100%.

Drug disorders (35%) are the most frequently diagnosed condition in this group of clients who received services from DMHAS operated or DMHAS funded treatment related programs. Over one fourth (28%) of the clients have a diagnosis of major mood disorder; while close to 20% have a diagnosis of major depression. When looking at primary and non-primary diagnoses, just over half of the clients qualify for an SMI (serious mental illness) diagnosis, which involves having any (or multiple) of the following diagnoses: Schizophrenia (including related disorders), Bipolar Disorder, or Major Depression. Almost 65% of clients have a substance use/abuse disorder. Almost one quarter (24%) of clients qualify for a dual diagnosis, meaning that they have both an SMI diagnosis and a substance abuse diagnosis.

Drug disorders (35%) are the most frequently diagnosed condition in this group of clients who received services from DMHAS operated or DMHAS funded treatment related programs. Over one fourth (27%) of the clients have a diagnosis of major mood disorder; while close to 20% have a diagnosis of major depression. When looking at primary and non-primary diagnoses, half of the clients qualify for an SMI (serious mental illness) diagnosis, which involves having any (or multiple) of the following diagnoses: Schizophrenia (including related disorders), Bipolar Disorder, or Major Depression. About 64% of clients have a substance use/abuse disorder. Almost one quarter (24%) of clients qualify for a dual diagnosis, meaning that they have both an SMI diagnosis and a substance abuse diagnosis.

The Diagnosis data had no significant changes from SFY13 to SFY14.

YOUNG ADULT SERVICES

Within the DMHAS system, Young Adult Services (YAS) serves clients who are ages 18-25 and have a history of DCF involvement. They must also have a history of a major mental health problem. These data represent unduplicated client counts. Clients are counted as YAS clients as long as they receive any YAS services. They may also receive non-YAS services.

In SFY13, YAS programs served 1,062 clients.

In SFY14, YAS programs served 1,117 clients.

The number of clients served in YAS programs increased 5.2% from SFY13 to SFY14.
