**Assessment Conversions** - Historical information has been brought over from DPAS and added to DDaP as Crisis, Jail Diversion and PTIP Assessments.



DDaP Maintenance Release 1.5 will be implemented this week. Please find below important information regarding this new release:

**1. File Format** - Allowable value '50 Domestic Violence Shelter' has been removed from Living Situation (field 59).

**2. New Features in DDaP -**

- Drug Rank** - Drug ranking is now required in the Periodic Assessment drugs section. Historical Drug ranking has been brought over from DPAS and Batch. Periodic assessments added online after conversion have not been ranked.

- Service Aggregation** - Non-Treatment programs can now aggregate minute based services for an entire month. And for daily services in non-treatment programs, the requirement that days be consecutive for aggregation has been removed.

**3. Validation Rules -**

- Periodic Assessment Date** - When discharging a client either online or through file submission, the periodic assessment date must be exactly the same as the discharge date if a periodic assessment is being submitted.

- Living Situation** - the 'Domestic Violence Shelter' response has been deleted and all existing periodic assessments that have the 'Domestic Violence Shelter' response have been changed to 'Homeless Shelter'.

- Number of Times Attended Voluntary Self-Help Group** - for question on periodic assessment, rule has changed to: "Number must be between 0 and 90, or 97".

**3. Validation Rules (continued) -**

- **Medicaid (both types)** - Rule added to require Medicaid policy # to be numeric and exactly 9 digits. The existing rule that requires that it begin with "001", "002", "003" or "004" has not changed.
