Agenda Item 1: Call to order and introductions

The meeting was called to order at approximately 2:30 PM by Chairman John Hamilton.

Agenda Item 2: Minutes of previous meeting review and action

The minutes from January 16, 2019 meeting were reviewed and accepted.

Agenda Item 3: Commissioner's Update

- Budget: Commissioner Delphin-Rittmon announced that the Appropriations Committee heard testimony on the proposed DMHAS budget two weeks ago and the subcommittee workgroup will meet next Wednesday. About 41 beds for Young Adult Services (YAS) in Hartford, Portland, Torrington and Bridgeport will be converted to community operations. There will be no layoff option with these changes, so staff will not lose their jobs. PNP Cost of Living Adjustments (COLA) were included in the Governor's budget and will be annualized. This should make a difference for providers. There is a proposed salary increase for collective bargaining staff, effective 7/1/19. Two annualized reduction to the grants line for \$1.6 million.
- Legislative Update: Mary Mason announced that language related to bills is still being rolled out.
 Gambling, sports wagering and online betting are hot topics in the legislature. Sober Home bills have died this year. On 3/25/19 the Public Health committee will hold hearings on <u>SB 1057</u> AN ACT CONCERNING OPIOID USE DISORDER, <u>SB 1101</u> AN ACT CONCERNING AN EVALUATION OF HOSPITALS OPERATED BY THE DEPARTMENT OF MENTAL HEALTH AND ADDICTION SERVICES, and <u>SB 859</u> AN ACT CONCERNING COMMUNITY HEALTH WORKERS. SB 1057 expands Medicaid to allow people with opioid use disorders to have home healthcare.
 - The General Law committee will hold public hearing on 3/22/19 for <u>HB 7371</u> AN ACT CONCERNING THE RETAIL SALE OF CANNABIS and <u>HB 7287</u> AN ACT CONCERNING REVISIONS TO THE MEDICAL MARIJUANA PROGRAM.
 - <u>HB 7200</u> AN ACT PROHIBITING THE SALE OF CIGARETTES, TOBACCO PRODUCTS, ELECTRONIC NICOTINE DELIVERY SYSTEMS AND VAPOR PRODUCTS TO PERSONS UNDER AGE TWENTY-ONE. Right now legislators are working on which agency, DRS or DCP, will work on the enforcement part of this bill. DMHAS will still be involved in compliance checks.
- Other: Role of mental health recovery support specialist, within the emergency room departments
 Karen Kangas said Hartford Hospital will have a mental health recovery support specialist very soon.
 Karen and Chyrell Bellamy are working on leading a discussion on the role of peers related to people who
 end up in emergency rooms for mental health issues and what programming related for that may look
 like. An email will go out so feel free to participate. That discussion will then be brought to the board for
 further discussion.

Agenda Item 4:

• Best Practices Subcommittee Update: Paul Acker is happy to announce that in as little as over two months the subcommittee was able to get a food truck that is now on the CVH campus in front of Haviland Hall. The food truck is called Vero, which has a restaurant in Middletown, and they do farm to table food service. The food truck is on campus Monday through Saturday. The subcommittee is also looking to expand and get another food truck.

The subcommittee is also reaching out to a couple of areas to start to find out where the experts are on best practices.

Commissioner Delphin-Rittmon said Kudos and thank you to the subcommittee for doing such a great job.
