ANNOUNCEMENT

Rulings and Administrative Pronouncements Obsoleted by Sales and Use Tax Regulations on Enumerated Services

PURPOSE: This Announcement identifies rulings and administrative pronouncements that have been obsoleted by the subsequent promulgation of sales and use tax regulations on enumerated services. The Department of Revenue Services (DRS) declares a ruling or pronouncement "obsoleted" where, because of changes in the law on which a ruling or pronouncement was based or because a position taken in a ruling or pronouncement has been addressed in a subsequently promulgated regulation, the ruling or pronouncement is no longer considered authoritative and should not be relied upon for future transactions.

By declaring a ruling or pronouncement to be obsoleted, DRS intends to eliminate unnecessary research and to reduce the possibility of erroneous decisions by taxpayers and tax practitioners. The fact that a ruling or pronouncement is obsoleted does not affect its past validity or its application to past transactions.

EFFECTIVE DATE: The following rulings and administrative pronouncements are no longer considered determinative for sales or purchases occurring on or after April 7, 1999, the effective date of the regulations discussed in this Announcement.
