**Identification of Recent Amendments to the International Fuel Tax Agreement Approved by the Department of Revenue Services**

---

**Purpose:** This Announcement identifies recent amendments to the International Fuel Tax Agreement (“Agreement”) that the Department of Revenue Services (DRS) has approved. Previous amendments to the Agreement that DRS has approved are identified in **Informational Publication 2001(23)**, *Connecticut IFTA Manual*.

**Effective Date:** Upon issuance.

---

**Statutory Authority:** Conn. Gen. Stat. §12-486(c)(2).

---

**Final Ballot Proposal #1-2001:** DRS has approved the amendment made to Sections R130, R140, R150, R239, R365, R370, R800, and R830 of the Agreement by Final Ballot Proposal #1-2001. The amendment is effective July 1, 2003.

---

**Final Ballot Proposal #2-2001:** DRS has approved the amendment made to Sections R1630, R1640, and R1650 of the Agreement by Final Ballot Proposal #2-2001. The amendment is effective November 26, 2001.

---

**Final Ballot Proposal #3-2001:** DRS has approved the amendment made to Section R1720 of the Agreement by Final Ballot Proposal #3-2001. The amendment is effective July 1, 2003.

---

**Final Ballot Proposal #4-2001:** DRS has approved the amendment made to Section R1510 of the Agreement and to Section A310 of the Audit Manual by Final Ballot Proposal #4-2001. The amendment is effective November 26, 2001.
