ANNOUNCEMENT

Quarterly List of Distributors for Motor Vehicle Fuels Tax Purposes

Purpose: This Announcement publishes the quarterly list of distributors that are licensed for motor vehicle fuels tax purposes. **Policy Statement 92(14.4)**, *Annual and Quarterly Lists of Distributors for Motor Vehicle Fuels Tax Purposes*, discusses the policy behind publishing an annual list and quarterly lists of persons being added to or deleted from the last list. Conn. Gen. Stat. §12-458(a) provides the statutory authority for publication of this information.
