ANNOUNCEMENT

Quarterly List of Distributors for Motor Vehicle Fuels Tax Purposes

Purpose: On or about January 31 of each year, the Department of Revenue services (DRS) publishes on its Internet web site (www.ct.gov/DRS) a list (annual list) of persons licensed as distributors for motor vehicle fuels tax purposes (licensed distributors). DRS updates the annual list on a quarterly basis (on or about April 30, July 31, and October 31 of each year) by publishing on the Internet web site a list (quarterly list) that identifies the persons that have become, or that no longer are, licensed distributors since the current annual list and any subsequent quarterly list(s) were published. Because quarterly lists are not cumulative, it is necessary to consult the current annual list, any subsequent quarterly list(s), and the current quarterly list to determine whether a person is a licensed distributor.
