Statutory Authority: Conn. Gen. Stat. §12-264(b)(3).

Definition: **DRS-registered natural gas supplier** is a natural gas supplier registered with DRS for purposes of the tax imposed under Chapter 212 of the Connecticut General Statutes (the utility companies' gross earnings tax).
