

# COMPLAINANT MOTION TO SET ASIDE, OPEN, RECONSIDER OCTOBER 9, 2013 RULING AND VACATE SEPTEMBER 12, 2013 ORDERS, RULINGS AND DECISIONS DUE TO LACK OF NOTICE AND VACATE OCTOBER 9, 2013 ORDER REQUEST FOR RECONSIDERATION

Pursuant to any and all applicable Connecticut General Statues, Connecticut Common Laws and all applicable Conn. Freedom Of Information Rules and Sections, NOW COMES THE COMPLAINANT Vernon J. Leftridge, Jr. who herby respectfully moves the FREEDOM OF INFORMATION COMMISSION to set aside October 9, 2013 decision for lack of notice of September 12, 2013 F.O.I. Hearing and VACATE September 12, 2013 decisions and rulings for the following reasons:

- 1. I the complainant never received any notice that the F.O.I. had rescheduled opposing counsel continuance to September 12, 2013;
- 2. Had I received actual notice of F.O.I. September 12, 2013 hearing, I would have appeared;
- 3. There would be no prejudice to either party because I never had any knowledge that the respondents had scheduled a hearing with F.O.I. Commissions on September 12, 2013, when complainant would have filed a short continuance had he knew of the blind schedule date;
- 4. Respondents to date still have not fully and properly complied to complainant F.O.I. Requests.
- Complainant learned of the September 12, 2013 F.O.I. Hearing on October 10, 2013 by verbal phone communication from the ombudsman F.O.I. Officer who represented that she mailed a certified letter of the 9/12/2013 hearing to a U.S. Post Office Box in Hartford in lieu of complainant F.O.I. filed appearance address.
- 6. Reconsideration, opening and vacating 9/12/13 decision is warranted due to lack of proper service of the hearing.
- 7. Complainant did not fail to prosecute 9/12/2013 F.O.I. Hearing due to lack of actual notice of the respondents rescheduled hearing.
- 8. Complainant was prejudice by the actions of assigned ombudsman and by

the lack of notice of respondents new continuance date of hearing, which, goes to bias.

WHEREFORE, For the forgoing reasons, COMPLAINANT respectfully moves the F.O.I. Commission to reopen and vacate 9/12/2013 decision for lack of service, lack of notice and insufficiency of service; set aside and reconsider its rulings, October 9, 2013 F.O.I. decision for the stated reasons and correct its F.O.I. docket of an alleged U.S, Post Box that complainant did not file any appearance of a P.O. Box. and whatever this Honorable F.O.I. Commission deems just, right, and appropriate without delay or interference by ombudsman handling F.O.I. case file. Respondents still have failed to fully comply to complainants outstanding F.O.I. Requests.
