WARNING: FOR ALL PUBLIC DEFENDER CLIENTS

If you are represented by an attorney from the Public Defender's Office, your attorney will meet with you to discuss your case and answer your questions. In the meantime:

- YOU SHOULD NOT DISCUSS YOUR CASE WITH ANYONE OTHER THAN YOUR ATTORNEY. If police officers, immigration agents (ICE) or other law enforcement agents ask to speak with you, tell them that you are represented by an attorney and that you do not wish to speak with them. Also, immediately ask for your lawyer. If you do not know your lawyer's name just ask to speak with your attorney.
- If you become incarcerated, prosecutors may ask DOC to monitor your mail and/or phone conversations.

 <u>Do not</u> discuss your case with anyone over the phone or by mail. <u>Only discuss your case with your attorney in person or through a private phone in your counselor's office.</u>

CONTACT WITH ANY OFFICIAL REGARDING YOUR IMMIGRATION STATUS

Immigration and Customs Enforcement ("ICE") agents may try to interview you or ask you to sign documents regarding your identity, place of birth, citizenship, immigration status, or criminal history. Anything you say to an ICE official could cause ICE to start deportation proceedings against you. If any ICE agents approach you on the street or come to your house or workplace you should not respond to any of their initial questions to determine your identity. Follow the advice below to protect yourself:

- (1) Do Not Give Out Your Name: If any strangers approach you on the street and ask for your name <u>do not respond</u>. Also, if any stranger calls out your name, <u>do not respond</u>. You are not required to give ICE your name or any identification. You have the right to remain silent.
- (2) Immigration interviews are voluntary: You are not required to speak to any ICE agent or provide your name, place of birth, citizenship/immigration status, or criminal history. If you become incarcerated you should not speak to any ICE agent at any DOC facility and you should DECLINE to be interviewed by ICE. Anything that you say to ICE or correctional officers working for ICE (including information about where you were born) can and will be used against you in immigration/criminal court. You should remain silent.
- (3) You do not have to sign any documents. Anything you sign at the request of ICE or correctional officers working with ICE can and will be used against you in immigration court. You should not sign any documents without the advice of your attorney.

Contact your lawyer if any ICE agents try to talk to you or detain you.
