Malloy, as Chairman, called the meeting to order at 10:33 a.m. on Tuesday, December 11, 2018 after noting the presence of a quorum and the Secretary of the Office of Policy and Management, as Secretary, recorded the minutes of the meeting.

Upon a motion duly made and seconded, it was voted to approve the minutes of the meeting held on September 20, 2018.

Thereupon there was submitted to the Commission, in writing, a proposed form of a resolution to authorize pursuant to Public Act 79-607 the issuance of the bonds referred to in the requests and entitled "Resolution of the State Bond Commission Authorizing \$14,096,143 Bonds of the State of Connecticut Pursuant to Public Act No. 79-607 of the General Assembly of the State of Connecticut, as amended."

After review and discussion of the documents so filed and submitted and upon motion duly made, seconded and carried, the Commission adopted the resolution as follows:

RESOLUTION OF THE STATE BOND COMMISSION AUTHORIZING \$14,096,143 BONDS OF THE STATE OF CONNECTICUT PURSUANT TO PUBLIC ACT NO. 79-607 OF THE GENERAL ASSEMBLY OF THE STATE OF CONNECTICUT, AS AMENDED

The State Bond Commission of the State of Connecticut, existing under and by virtue of Section 3-20 of the General Statutes of Connecticut and consisting of the Governor, the Treasurer, the Comptroller, the Attorney General, the Secretary of the Office of Policy and Management, the Commissioner of the Department of Administrative Services, the Co-chairpersons and the ranking minority members of the Committee on Finance, Revenue and Bonding of the General Assembly, of the State,

DOES HEREBY FIND THAT there has been filed with the State Bond Commission one or more requests by or on behalf of the Secretary of the Office of Policy and Management of the State of Connecticut for the authorization of the bonds hereinafter mentioned, dated December 11, 2018 and entitled "Request Nos. 1442, 1443, 1444, 1445, 1446, 1447, 1448, 1449, 1450, 1451 and 1452 to the State Bond Commission Pursuant to Section 21(a) of Public Act No. 79-607 of the General Assembly of the State of Connecticut, as amended, for Authorization of \$14,096,143 Bonds of the State under Section 21(a) of said Act";

THAT said requests are signed by or on behalf of the Secretary of the Office of Policy and Management or by or on behalf of an officer, department, or agency referred to in the Act, and all such terms and conditions as the State Bond Commission requires are stated therein and the request or requests are in all other respects sufficient for authorization of bonds of the State under or pursuant to Section 21(b)(6)(B) of Public Act No. 79-607 of the General Assembly of the State of Connecticut, as amended;

THAT, there has been filed with the State Bond Commission all other documents required by subsection (g) of Section 3-20 of the General Statutes of Connecticut or by the State Bond Commission, including any human services facility colocation statement to be filed with the Secretary of the Office of Policy and Management, if so requested by the Secretary, pursuant to Section 4b-23, as amended, of the General Statutes, any statement from the Commissioner of Agriculture pursuant to Section 22-6 of the General Statutes for projects which would convert twenty-five acres or more of prime farmland to a non-agricultural use, any capital development impact statement required to be filed with the Secretary of the Office of Policy and Management, if so required by the Secretary, pursuant to Section 4b-23, as amended, of the General Statutes, a statement as to the full cost of the project or purpose when completed and the estimated operating cost for any structure, equipment or facility to be constructed or acquired, and any advisory statement regarding the State Conservation and Development Policies Plan required by Section 16a-31 of the General Statutes; and THAT the authorization of such bonds will be in the best interests of the State; and

THAT in accordance with Section 3-20(g)(1)(A)(ii) of the General Statutes, the State Bond Commission finds that the authorization of such bonds, together with all bond authorizations approved this calendar year including on the date hereof, in the aggregate do not exceed the

calendar year limit established in accordance with Section 3–20(d)(2) of the General Statutes of Connecticut; and

DOES HEREBY DIRECT THAT all federal, private and other moneys now available or hereafter to be made available for costs in connection with the project described and identified in said request by or on behalf of the Secretary of the Office of Policy and Management shall be added to the State moneys available or becoming available under said Act for such project and be used for such project as if constituting such State moneys; and

DOES HEREBY RESOLVE THAT:

Section 1. The amount of Community Conservation Development Bonds authorized to be issued pursuant to Section 21(a) of Public Act No. 79–607 of the General Assembly of the State of Connecticut, as amended, is hereby increased by \$14,096,143 in order to provide funds for the purposes and projects described in the requests submitted by or on behalf of the Secretary of the Office of Policy and Management and entitled “Request Nos. 1442, 1443, 1444, 1445, 1446, 1447, 1448, 1449, 1450, 1451 and 1452 To The State Bond Commission Pursuant To Section 21(a) Of Public Act 79–607 Of The General Assembly Of The State Of Connecticut, As Amended, For Authorization Of \$14,096,143 Bonds Of The State”, dated December 11, 2018 and hereby approved and ordered to be filed with the records of this meeting.

The aggregate amount of Community Conservation Development Bonds authorized to date pursuant to Section 21(a) of Public Act No. 79–607 and unissued to date, including the \$14,096,143 authorized by this resolution, is \$334,875,297.74. Bonds in the principal amount of \$1,449,612,245.26 (Series A through Series WW), have previously been issued.

Section 2. The form, date, maturities and other details of such authorized but unissued bonds shall be hereafter determined by this Commission or by the State Treasurer acting in accordance with procedures to be established by this Commission.

Under Section 21(b)(6)(B) of the above–mentioned Public Act, the State Bond Commission voted¹⁵ to approve a request of the Department of Energy and Environmental Protection for the reauthorization of unexpended funds in the aggregate amount of \$1,000,000 to provide a grant–in–aid to City of Hartford. The purpose of this request is to provide a grant–in–aid to City of Hartford for renovations to said building for City purposes. Said previously allocated funds are available from funds approved at the June 4, 2012 State Bond Commission meeting (Item 21(I)(B), Request 1133) to provide a grant–in–aid to City of Hartford on behalf of John E. Rogers African American Cultural Center, Inc. to assist with renovations and improvements to former Northwest District School at 1240 Albany Avenue for use by the Center.

Under Section 21(b)(6)(B) of the above–mentioned Public Act, the State Bond Commission voted¹⁶ to approve a request of the Office of Policy and Management for the reauthorization of unexpended funds in the aggregate amount of \$500,000 to provide a grant–in–aid to City of Norwich to assist with replacement of its police radio system, a request of the Department of Energy and Environmental Protection for the reauthorization of unexpended funds in the aggregate amount of \$300,000 to provide a grant–in–aid to City of New Haven to assist with creation of The Lost Generation Memorial Garden dedicated to victims of gun violence, a request of the Department of Economic and Community Development for the reauthorization of unexpended funds in the aggregate amount of \$353,654 to provide a grant–in–aid to McGivney Community Center, Inc. to finance demolition of the adjacent former Saint Charles Church School for parking and outdoor recreation space, a request of the Department of Economic and Community Development for the reauthorization of unexpended funds in the aggregate amount of \$200,000 to provide a supplemental grant–in–aid to TheaterWorks, Inc. to assist with renovations and improvements to its facility at 233 Pearl Street in Hartford, a request of the Department of Economic and Community Development for the reauthorization of unexpended

funds in the aggregate amount of \$200,000 to provide a grant-in-aid to Wadsworth Atheneum to assist with improvements to the Avery Memorial to increase display space and provide for increased ADA compliant access, a request of the Department of Economic and Community Development for the reauthorization of unexpended funds in the aggregate amount of \$200,000 to provide a grant-in-aid to New Britain Museum of American Art to assist with replacement of its HVAC chiller, a request of the Department of Economic and Community Development for the reauthorization of unexpended funds in the aggregate amount of \$500,000 to provide a grant-in-aid to Connecticut Association for the Performing Arts d/b/a The Shubert Theater in New Haven to assist with Phase II of renovations and improvements under its centennial plan, a request of the Department of Economic and Community Development for the reauthorization of unexpended funds in the aggregate amount of \$37,000 to provide a grant-in-aid to City of Norwalk on behalf of Rowayton Historical Society to assist with restoration of the Frank E. Raymond Maritime Museum and Boathouse, a request of the Department of Economic and Community Development for the reauthorization of unexpended funds in the aggregate amount of \$1,500,000 to provide a grant-in-aid to Sea Research Foundation, Inc. d/b/a Mystic Aquarium to assist with installation of tanks and related equipment for aquaculture, breeding, animal holding and quarantine in its animal care facility, a request of the Department of Housing for the reauthorization of unexpended funds in the aggregate amount of \$750,000 to provide a grant-in-aid to Housing Development Fund to assist with establishment of a Community Land Trust program in the South End of Stamford to provide permanently restricted affordable housing units to serve households at or below 50% of area median income, a request of the Department of Public Health for the reauthorization of unexpended funds in the aggregate amount of \$1,000,000 to provide a grant-in-aid to Fair Haven Community Health Care for alterations, renovations and improvements to its facilities at 350 and 374 Grand Street in New Haven and a request of the Department of Public Health for the reauthorization of unexpended funds in the aggregate amount of \$500,000 to provide a grant-in-aid to Regional Hospice and Palliative Care in Danbury to assist with renovations to its facility to create four additional patient suites . Said previously allocated funds are available from funds approved at the July 25, 2018 State Bond Commission meeting (Item 39(l)(A), Request 1383) to provide a grant-in-aid to Town of Orange for purchase, and related acquisition and planning costs, of land at 28 Salemme Lane for future transit oriented development, which funds are available for reallocation.

SECTION 32-142 OF THE CONNECTICUT GENERAL STATUTES

Under subsection (b) of Section 32-142 of the Connecticut General Statutes, when the General Assembly is not in regular or special session, the Commission may, on its own initiative, modify any private activity bond allocation established under Section 32-141 of the Connecticut General Statutes upon determining that such action would be in the best interests of the State. The Secretary of the Office of Policy and Management or his designee then proceeded to explain and discuss with the Commission the item. After review and discussion of the item, and upon a motion duly made, seconded and carried by unanimous vote, the Commission adopted the resolution as follows:

RESOLUTION AUTHORIZING THE CARRYFORWARD OF \$126,579,789 OF 2018 VOLUME CAP AND APPROVAL FOR ITS USE BY THE CONNECTICUT HOUSING FINANCE AUTHORITY FOR SINGLE OR MULTIFAMILY REVENUE BONDS AND BY THE CONNECTICUT HIGHER EDUCATION SUPPLEMENTAL LOAN AUTHORITY FOR STUDENT LOAN REVENUE BONDS; AND IT IS FOUND AND DETERMINED THAT APPROVAL OF THIS ACTION WOULD BE IN THE BEST INTERESTS OF THE STATE

RESOLVED: That the carryforward of the 2018 Volume Cap of \$126,579,789 and approval for its use by the following authorities in the following amounts and for the following purposes is hereby approved and ordered: \$116,703,728 to the Connecticut Housing Finance Authority for Single or Multifamily Revenue Bonds and \$9,876,061 to the Connecticut Higher Education Supplemental Loan Authority for Student Loan Revenue Bonds; and that this action is in the best interests of the State; and that said approval be filed with the records of this meeting.

CLEAN WATER FUND REVENUE BOND SALE AND REFUNDING REVENUE BOND SALE

Upon a motion duly made and seconded it was voted to adopt the following:

RESOLUTION OF THE STATE BOND COMMISSION AUTHORIZING (i) THE TREASURER TO ISSUE AND SELL AN AMOUNT NOT TO EXCEED \$250,000,000 STATE REVOLVING FUND GENERAL REVENUE BONDS OF THE STATE, SERIES 2019A, PURSUANT TO PUBLIC ACT NO. 86-420 OF THE FEBRUARY 1986 SESSION OF THE GENERAL ASSEMBLY OF THE STATE OF CONNECTICUT, AS AMENDED; (ii) ADOPTING A SUPPLEMENTAL RESOLUTION; (iii) THE TREASURER TO ISSUE AND SELL AN AMOUNT NOT TO EXCEED \$125,000,000 STATE REVOLVING FUND REFUNDING GENERAL REVENUE BONDS OF THE STATE, SERIES 2019B, PURSUANT TO PUBLIC ACT NO. 86-420 OF THE FEBRUARY 1986 SESSION OF THE GENERAL ASSEMBLY OF THE STATE OF CONNECTICUT, AS AMENDED; AND (iv) ADOPTING A REFUNDING SUPPLEMENTAL RESOLUTION.

BE IT RESOLVED BY THE STATE BOND COMMISSION OF THE STATE OF CONNECTICUT AS FOLLOWS:

Section 1. In accordance with Public Act No. 86-420 of the February 1986 Session of the General Assembly of the State of Connecticut, as amended (the "Act"), the State Treasurer is hereby authorized to issue and sell State Revolving Fund General Revenue Bonds of the State (the "General Revenue Bonds") authorized by this Commission to be issued in the aggregate principal amount not to exceed \$250,000,000 and State Revolving Fund General Revenue Refunding Bonds of the State (the "Refunding Bonds" and, together with the General Revenue Bonds, the "Bonds") authorized by this Commission to be issued in the aggregate principal amount not to exceed \$125,000,000. The Treasurer is delegated the authority to determine the terms and particulars of the Bonds, including any series designation or other action as may be considered necessary or desirable in connection with the issuance and sale of the Bonds, in accordance with the provisions of the resolution hereinafter mentioned.

Section 2. The Treasurer is authorized to sell such Bonds at public sale on sealed proposals or by negotiation, in such manner, at such price or prices, at such time or times, and on such terms and conditions as the Treasurer shall determine to be in the best interests of the State.

Section 3. Pursuant to the State Revolving Fund General Revenue Bond Program General Bond Resolution adopted on December 17, 2002 (the "General Resolution") and in accordance with Section 9 of the Act, the issuance of the General Revenue Bonds, shall be authorized by a Supplemental Resolution of the State containing the terms and conditions of its issuance and delivery. The Supplemental Resolution submitted to this Commission entitled "A Supplemental Resolution Authorizing the Issuance of \$250,000,000 State Revolving Fund General Revenue Bonds" (the "Supplemental Resolution") is hereby approved, with such changes, substitutions, deletions, additions or amendments as the Treasurer shall determine to be necessary or appropriate, in the best interest of the State and in accordance with the intent of its passage at this meeting, and any and all delegations of authority granted under the Supplemental Resolution to the Treasurer are hereby expressly ratified.

Section 4. Pursuant to the General Resolution and in accordance with Section 9 of the Act, the issuance of the Refunding Bonds, shall be authorized by a Refunding Supplemental Resolution of the State containing the terms and conditions of its issuance and delivery. The Refunding Supplemental Resolution submitted to this Commission entitled "A Refunding Supplemental Resolution Authorizing the Issuance of \$125,000,000 State Revolving Fund Refunding General Revenue Bonds" (the "Refunding Supplemental Resolution") is hereby approved, with such changes, substitutions, deletions, additions or amendments as the Treasurer shall determine to be necessary or appropriate, in the best interest of the State and in accordance with the intent of its passage at this meeting, and any and all delegations of authority granted under the Refunding Supplemental Resolution to the Treasurer are hereby expressly ratified.

Section 5. The Treasurer is hereby further authorized to cause the preparation and distribution of one or more Preliminary Official Statements of the State for use in connection with the offering and sale of the Bonds. Upon the sale of the Bonds, the Treasurer shall prepare and distribute one or more final Official Statements and is hereby authorized to execute and deliver such Official Statements to the purchasers of the Bonds in the name and on behalf of the State.

Section 6. This resolution shall take effect immediately.
