

AGENCY PURPOSE

- To uphold the laws of the state by determining the guilt or innocence of persons accused of crimes.
- To interpret state statutes and to determine whether a challenged law is unconstitutional.
- To resolve disputes involving civil or personal rights.
- To create and sustain a full range of alternatives to incarceration for both pre- and post-conviction adult and juvenile populations.
- To advocate for victims of crime and arrange for or provide services and financial compensation.
- To effectively resolve family and interpersonal conflicts through a comprehensive program of negotiation, mediation, evaluation and education.
- To supervise probationers in the community and to promote improvement in their conduct and condition.

- To provide safe and secure custody, treatment and rehabilitative services for children and families through the juvenile justice system.
- To ensure the principles of fair and reasonable bail by interviewing all detained criminal defendants to determine whether they should remain incarcerated while their cases are pending.
- To enforce, review and adjust child support orders.
- To maintain secure and safe conditions in courthouses and other Judicial Branch facilities.
- To provide for the transportation of prisoners between courthouses and places of confinement.

RECENT HIGHLIGHTS

Expanded Judicial Branch Website

Enhancements include allowing submission of short calendar markings via the website, providing electronic access to small claims and housing case information. In addition, the Branch began the work necessary to move towards electronic filing -- allowing court documents to be filed via the website.

Relocated the Appellate Court

Moved to a dedicated facility located at 75 Elm Street in Hartford. In addition, a lease was entered into for the building at 90 Washington Street in Hartford, which will provide the Judicial Branch with ten additional courtrooms as well as much needed office space.

Implemented the Case Management Information System (CMIS), July 2003.

This automated intranet-based system is designed to improve the timeliness and quality of services provided to the court by Judicial Branch staff members. The first phase of CMIS includes Bail Commission functions and Adult Probation Case Tracking.

Opened the Hartford Juvenile Detention Center, Jan 2004

This 58,000 square foot facility features state of the art accommodations and supervision services for 88 boys and girls in gender-specific units, as well as a separate medical/mental health unit, classrooms and a large recreation area for outside activities.

Developed the Paperless Re-Arrest Warrant Network (PRAWN)

In collaboration with various state agencies, the goal of this database is to make all rearrest warrants, now at nearly 40,000, known to law enforcement immediately upon issuance as long as they are active.

Expanded the Number of Court Service Centers

These centers, located in courthouses, help guide countless pro se litigants and attorneys through the court process by providing court forms, court publications, copy machines, fax machines, case information and children's centers now in the New Britain, Stamford and Bridgeport Superior Courts.

Accredited Nationally by the American Correctional Association, May 2003

This accreditation, to all three juvenile detention centers operated by the Branch, was based in large part on the professionalism of the detention staff, and comprehensive continuum of services provided to the juveniles housed in the centers.

Adopted a Risk Assessment Tool

The Family Criminal Violence Risk Assessment Project resulted in a new assessment tool to be used at arraignment to determine the level of risk in family violence cases by predicting possible violent behavior, thereby enhancing victim safety.

PUBLIC DEFENDER SERVICES COMMISSION

AGENCY PURPOSE

- Ensure the constitutional administration of criminal justice within the state criminal court system by maintaining a public defender office at all court locations throughout the
- Provide legal representation to indigent accused in criminal trials and appeals, extradition proceedings, habeas corpus proceedings arising from a criminal matter, delinquency matters, and Psychiatric Security Review Board cases.
- Provide social work services to clients to assist them in addressing and resolving personal and social problems, which lead to arrest and prosecution.
- Contribute to crime prevention by participation in specialized programs, including Domestic Violence Courts, Community Courts, Diversionary Programs, Alternatives to Incarceration and Team Case Management.
- Provide a balanced perspective within the criminal justice community by participation on state policy boards, task forces, and committees involved in addressing criminal justice issues.
- Fulfill the State's constitutional obligation to provide counsel for indigent accused in a professional, effective and cost efficient manner.

RECENT HIGHLIGHTS

- Continued to concentrate on crime prevention by assisting clients in addressing substance abuse, mental illness, employment, housing and other issues that have contributed to their involvement in the criminal justice system.
- Continued to expand its focus on the representation of juvenile clients in delinquency proceedings.
- Improved its Special Public Defender program in the areas of compensation, training and litigation support for private attorneys appointed by the court to handle conflict of interest cases on a contractual and non-contractual basis.
- Ranked amongst the highest in total federal grant dollars received by a statewide indigent defense program. In FY2003-04 the Division received \$897,300 in federal Byrne Grant funds and \$1.01 million in Juvenile Accountability Incentive Block Grant funds. In total, the Division was awarded \$1.9 million for team case management and juvenile program expansion.
