Dear Comptroller Lembo:

The following information on the state's General Fund for fiscal year 2017 is provided in accordance with Section 4-66 of the General Statutes. In addition, an analysis of the Special Transportation Fund is included due to the significant nature of this fund.

General Fund

We project a \$0.2 million balance from operations. On the expenditure side, the adopted budget includes substantial lapse assumptions, the achievement of which will present significant management challenges for all branches of government. With respect to revenues, it is worth noting that several sources, including the Personal Income Tax, Sales and Use Tax, and Corporation Tax, ended FY 2016 below expectations and bear watching during FY 2017. Our estimate of the balance in the Budget Reserve Fund entering FY 2017 is \$195.3 million, subject to any final adjustments by the Comptroller's office for Generally Accepted Accounting Principles and audit revisions.

Our estimate assumes that the line item vetoes announced on June 2nd will offset any unbudgeted expenditures resulting from enactment of Public Act 16-82, An Act Concerning Health Insurance Coverage for Tomosynthesis for Breast Cancer Screenings, as well as failure to pass Emergency Certified Bill 501, which would have implemented budgeted savings associated with specific criminal justice policy changes. The budgetary impact of these areas will be monitored as the year progresses, and future forecasts will be adjusted accordingly.

Special Transportation Fund

The adopted budget anticipates a \$1.0 million balance from operations. Estimated revenues and expenditures remain unchanged relative to the adopted budget. We anticipate the fund balance on June 30, 2017 to be \$151.4 million.

It is important to note that this represents the first projection of the state's General Fund and Special Transportation Fund positions for FY 2017. As the year progresses, these estimates will undoubtedly be revised to reflect the impact of changes in the economy, expenditure patterns, and/or other factors.
