Monthly Indicators Report

Highlights

- On August 1st, 16,569 prisoners were incarcerated in state prison facilities. Last year on the first, there were 17,142 people in Connecticut prison facilities.
- Chart 2a contains data on changes in discretionary-release caseloads from the near-complete suspension of paroles in the aftermath of the Cheshire murders in 2007 through to the present. The volume of releases increased moderately from 2008 to 2011. Since then, however, the number of offenders on Parole, Transitional Supervision or Transitional Placement have declined by almost 40%.
- The number of offenders living in halfway houses is down by 8% compared to the same time last year (see table 2). This drop dates back to October 2013, when the DOC terminated its contract for residential beds with the Norwalk non-profit, NEON Inc.
- A backlog in parole-case hearings appears to be easing. During July, paroles were granted in 125 cases. During May, only 73 offenders were granted parole, significantly fewer than the 149 granted during May 2013. In contrast, the Board approved 243 paroles in May 2010.
- Pretrial admissions in July were down 7.6% compared to 2013 (see table 3). Statewide criminal arrests were also down (5.3%) during the same period.

Prison Population Forecast

The average prison population during the first week in August was lower, by 184 inmates, than the figure projected by OPM in February.

OPM expects the prison population to begin growing steadily through

October. Were current patterns to persist, it is not unreasonable to assume that the prison population could dip below 16,300 on January 1st.

OPM does not consider trends in the overall state crime rate in producing its short-term projections of the prison population. Analysis reveals that fluctuations in the prison population are not directly influenced by the crime rates. Rather they are more dependent on systemic factors like changes in policies, procedures, staffing, etc.

Seasonal considerations are also very important.

That said, overall crime rates appear to be dropping steadily both in the state and nationally. Rethinking the application of drug-laws and re-directing youth away from incarceration appears to be having a cumulative effect on declining prison counts and prison admissions.

Chart 1 – Actual prison population against the OPM forecast




Chart 2 - Criminal justice, monthly counts and flows




The number of offenders completing their prison sentences in discretionary community supervision programs has decreased dramatically over the last three years. On August 1st, 2011, 2,809 offenders were on either Parole (including Parcom), Transitional Supervision or Transfer Placement status. By 2014, that figure had fallen to 1,713, a 38.2% drop.

Although the sentenced prison population declined during the same period, it fell much less precipitously – from 13,523 to 12,451 – a 7.9%

drop. In 2011, there were 4.9 sentenced offenders incarcerated for every offender in a non-residential community supervision program. By 2014, that ratio had jumped to 7.3 offenders in prison for every community placement. Several factors appear to be driving this change. Legislation, passed last year, and procedural changes at the Board of Pardons and Paroles have certainly affected the flow of offenders to Parole. Less clear are the factors that have pushed down the number of offenders on Transitional Supervision.

August 1, 2014 to August 7, 2014




Chart 4 – Prison population, first-of-month 2013 and 2014




Chart 5 – Statewide criminal arrests




Chart 6 - Monthly DOC Admissions

June 2013 through July 2014




Chart 7– Remands from community release

July 2014





Chart 8 – DOC community supervision
