Monthly Indicators Report

Highlights

- The prison population remained relatively stable during September. On October 1st, 16,610 people were incarcerated in Connecticut. A month earlier, there were 16,557 prisoners in state prison facilities.
- The state's prisons and jails held 493 fewer inmates October 1st 2014 than they did on the same date in 2013 (see chart 4). It is noteworthy that the entire drop in the prison population is smaller than the drop in the pre-trial population which fell by 560 during the same period (see table 2).
- The number of parole hearings continues to rise. The Board of Pardons and Paroles heard 210 cases during September. The last time the Board heard more cases was in April 2012.
- Gov. Malloy, this month, appointed Kenneth Ireland to the state Board of Pardons and Paroles. Ireland, 44, had served 21 years of a 50-year prison sentence, in CT, before he was exonerated of the crimes of rape and murder in 2009. Malloy also appointed Joy Chance, Rufaro Berry, Patricia Thomas Camp and Terry Borjeson to the Board.
- The number of offenders on supervised parole continues to decline (see chart 8). This October 1st, excluding Parole Compact cases, 754 offenders were on parole in CT. Three years ago, in 2011, 1,443 offenders were on parole status.

Prison Population Forecast

Last month this paper reported that August prison admissions were down 7.5% compared to August 2013. During September, prison admissions were also down compared to last year's figures. This time

by 5.2%. It remains unclear why an anticipated summertime bump in the prison population never emerged. As of the first week in October, the prison population was about 370 prisoners below what OPM had projected in February.

The data for 2014 shown on Chart 4 illustrates how flat the prison population has been since early March. This paper, likes to remind readers about the seasonal ebbs and flows in the prison population and about how stable and predictable these changes are.

Either 2014 will prove to be an atypical year in terms of the prisons or the old model that relied on seasonal fluctuation will need significant reworking. OPM's research unit has added staff, which should result in improvements to this monthly publication and the overall prison forecast model.

Chart 1 – Actual prison population against the OPM forecast





Chart 2 - Criminal justice, monthly counts and flows




Chart 2 is a rather complicated and perhaps confusing attempt to portray the aggregated movement of offenders through the state's criminal justice system each month.

For new criminal cases, the front end of the system is reflected in the number of new arrest dockets filed with the courts. Following arrest, offenders may be released on their own recognizance or they made be issued a surety bond to guarantee their appearance at court.

Offenders unable to post bond are generally admitted to a DOC facility to await the disposition of their cases. Chart 2a illustrates how the volume of bail cases opened each month fluctuates in roughly the same pattern as pre-trial prison admissions.

Between 2009 and 2013, the number of arrests recorded annually dropped by 23.7%. The number of new bail cases, however, declined by only 11.2%. Pre-trial prison admissions were down 15.9% during the same period.

October 1, 2014 to October 7, 2014




Chart 4 – Prison population, first-of-month 2013 and 2014




Chart 5 – Statewide criminal arrests




Chart 6 – Monthly DOC Admissions

August 2013 through September 2014




Chart 7– Remands from community release
September 2014





Chart 8 – DOC community supervision
