OPM - Criminal Justice Policy & Planning Division Monthly Indicators Report

Highlights

- On May 1st there were 13,037 inmates in Connecticut prisons and jails, down nearly 500 offenders from one year ago. On May 10th the prison population dipped below 13,000 for the first time since September 1993. As of this writing it continues to hover near the 13.000-inmate level.
- The women's prison population has fallen more than 13% since February. Men, held on pretrial status are down 2%. Given the small number of women in prison relative to men, large percentage swings can and have happened. Of particular interest to forecasters this year, the women's population has fallen by 122 offenders from its annual peak, this may account for most of the difference between the actual and forecasted prison populations seen in Table 1.
- There is striking overlap between the state's prison population and people that enter the state's shelter system. This month in chart 2a we show that overlap as it relates to age and gender.
- Statewide arrests, a measure we track as a primary input to the criminal justice system, continues to decline (chart 5). Year-to-date, arrests are down 6% compared to 2018 and 26% from 2014.
- Parole releases are down 20% compared to 2018. BOPP has effectively cleared any hearing backlog it may have had. Given a much smaller sentenced population and consistent grant rates at BOPP, the number of offenders granted parole each are month is shrinking in step with the overall population decline (table 4).

Prison Population Forecast

The prison population is down 3% from its annual peak on February 1st, a steeper decline than usually seen. We have observed in this space that the sentenced population has been the primary driver of the prison population decline for several years now. Things are a bit different this year as most of the decline (68%) has come as a result in a drop in pretrial offenders. Offenders on pretrial status make up only about one quarter of the total prison population.

The pretrial population has been driven down by drops to its inputs and relative increases to its outputs. On the front end, pretrial admits, year-to-date, have been lower than last year, down 8%.

On the back end, OPM tracks two output "valves" for the pretrial population – the number of offenders bonding out from a DOC facility and those that are released, for any reason, at court. Those metrics reveal something interesting. Offenders

bonding out of facilities has fallen at the same rate as pretrial admits. The number of pretrial offenders being released at court has held constant over the first four months of the year, despite 400 fewer pretrial admits than last year, providing additional downward pressure on the number of pretrial detainees.




Chart 2 - Criminal justice, monthly counts and flows




The Criminal Justice Research Unit at OPM recently teamed with the CT Coalition to End Homelessness (CCH) to discuss a data-sharing project to determine the degree to which the state's homeless population overlapped with the state's formerly-incarcerated population.

CCH provided OPM with data on over 17,000 individuals who had entered the state's shelter system during the last 3 years. OPM matched the CCH data with DOC inmate records. This effort revealed that 48% of the people that entered the state's shelter system in the last 3 years had been

former CT DOC inmates. Approximately 45% of the people that were matched had been released from prison within the last 3 years.

Although this analysis is preliminary, it appears that shelter utilization rates among former DOC inmates varies dramatically by age and gender. While only 25% of CCH women could be match with DOC records, we found a 61% match for men. Among men in the CCH dataset who were between the ages of 41 to 49, we found a CT DOC match rate of 70%.

First week of the month, avg. daily count (ADC)




Chart 4 – Prison population, first-of-month 2016, 2017, 2018 and 2019




Chart 5 – Statewide criminal arrests 2018 and 2019




Chart 6 - Monthly DOC Admissions

Mar. 2018 through Apr. 2019




Chart 7– Remands from community release





Chart 8 – DOC community supervision Apr. 1, 2018 through May. 1, 2019
