Section 26 of Public Act 09-1 requires the Secretary of the Office of Policy and Management to "monitor expenditures for personal services agreements and consultant agreements for executive branch agencies during the fiscal year ending June 30, 2009", and to "take such action as necessary to reduce expenditures for such purpose by two million dollars" during the current fiscal year.

The Secretary is further directed to submit a report to your committees "identifying reductions of at least eight million dollars in the aggregate in the cost to executive branch agencies for personal services agreements and consulting agreements" during this fiscal year. That \$8 million savings is in addition to the \$2 million in savings referred to above.

The Office of Policy and Management has identified a number of contract terminations which are expected to result in significant FY 2009 savings. State agencies are in the process of terminating those agreements and the exact savings, as well as the cost of termination, will not be known until that process is completed. However, we expect the savings to be substantially in excess of \$10 million in this fiscal year, with additional savings in the future.

In addition, the Office of Policy and Management has increased its scrutiny of personal service agreements, in order ensure that all such agreements are essential to the conduct of state business. We expect that process to result in significant savings both this year and in the future.

Finally, we have identified additional personal service agreements and memorandums of understanding which agencies will be directed to either renegotiate or not to renew when they expire. The savings resulting from those actions remain to be determined.

Attached is a list of the PSA's and MOU's designated for termination and the FY 2009 savings associated with those actions.
