### **V. Items Requiring Action**

The Board considered agenda item V.A., In the Matter of Kevin Muhammad, Certification Action, at this time.

#### **A. In the Matter of Kevin Muhammad, Certification Action**

In consideration of agenda item V.A., In the Matter of Kevin Muhammad, Certification Action, Assistant Attorney General Kerry Colson was present to represent and counsel the State Board of Education. Legal Director Jessa Mirtle, Division of Legal and Governmental Affairs, and Nancy Pugliese, Chief of the Bureau of Investigations and Professional Practices, were present to represent the Commissioner of Education.

Chairperson Taylor questioned the presence of Mr. Muhammad at this meeting. Attorney Jessa Mirtle responded that they were not aware of Mr. Kevin Muhammad being present. Assistant Attorney General Kerry Colson questioned if Mr. Kevin Muhammad had received notice of the hearing. Attorney Jessa Mirtle responded in the affirmative that Mr. Kevin Muhammad had been provided with notice of today's hearing. It is duly noted in the meeting minutes that the Mr. Kevin Muhammad had been notified of the Board hearing.

The members of the Board were presented with a draft resolution to vote on the intended form of penalty. The Board engaged in questions and answers concerning the resolution on the floor that required a roll call vote.

- Determines by a roll-call vote that the professional certificate endorsed for biology grades 7 through 12 of the holder shall be revoked and the provisional certificate endorsed for intermediate administration and supervision for grades K through 12 of the holder shall be revoked;
- Certifies that each member has read the written report of the Commissioner;
- Bases this determination upon its conclusion that the evidence supports a finding of misconduct sufficient to revoke the professional certificate and revoke the provisional certificate and adopts the evidence and conclusions outlined in the written report of the Commissioner; and
- Directs the Commissioner to take the necessary action.

#### Overview of Racial Imbalance

Prior to the Hamden panel presentation to the Board, Legal Director Jessa Mirtle introduced State Department of Education Attorney Laura Anastasio to provide a PowerPoint overview on the Racial Imbalance Statutes and Plans. Attorney Anastasio explained the historical significance of the Racial Imbalance Statute of 1969 and the definition of racial imbalance. This statute requires the CSBE to notify a school district if it finds that a school under its jurisdiction is racially imbalanced. Attorney Anastasio spoke on the regulations and on the calculation of racial imbalance, the content of racial imbalance plans, and State Board of Education considerations of the plans.

The Board thanked Attorney Anastasio for the overview presentation.

**B. Consideration of Hamden Board of Education's Plan to Address Racial Imbalance in Church Street School**

A panel consisting of Superintendent Jody Goeler, Hamden Public Schools and Chair Christopher A. Daur, Hamden Board of Education, presented a PowerPoint presentation to the Board on Hamden's districtwide efforts to balance elementary schools.

López moved, Mr. Harris seconded, that the State Board of Education, pursuant to Section 10-226d of the Connecticut General Statutes, conditionally approves the Hamden Board of Education's "2019 Plan to Address Racial Imbalance in Church Street School" conditioned upon the following:

1. That the Hamden Board of Education provide a detailed timetable for meeting interim progress benchmarks toward full implementation of its plan, including any such additional measures approved by the Hamden Board; and
2. That the Hamden Board of Education shall provide interim reports to the Commissioner on its progress in implementing the actions detailed in its timeline in December 2020 and December 2021;

and directs the Commissioner to take the necessary action.

A panel consisting of Superintendent Joseph Macary, Vernon Public Schools, and Assistant Superintendent Robert Testa presented Vernon's action strategies plan of addressing racial imbalance issues to the Board. Vernon presented a handout to the Board. Discussion ensued concerning the education of parents and guardians about racial identification.

1. That the Vernon Board of Education provide a detailed timetable for meeting interim progress benchmarks toward full implementation of its plan, including any additional measures approved by the Vernon Board; and
2. That the Vernon Board of Education shall provide interim reports to the Commissioner on its progress in implementing the actions detailed in its timeline in May 2020 and May 2021;

and directs the Commissioner to take the necessary action.

### Social Media Campaign Update

The Commissioner invited Communications Director Peter Yazbak to the table for a Social Media update. Mr. Yazbak spoke on the 52/52 Campaign to get 5,200 Followers in 52 weeks for both Facebook and Twitter. He reported that good progress was being made.

Commissioner Cardona reiterated that we must promote the positive things going on in Connecticut, and our social media campaign is being used to promote our best practices.

Dr. Estela López and Mrs. Erin Benham were presented with certificates for being *Top Fans* for spreading and promoting the SDE's social media platforms.

## **VIII. Financial Matters**

Chief Financial Officer Kathy Demsey reported that the SDE budget was on track and in good shape this year. Ms. Demsey spoke on another Finance Department project. She stated that in response to requirements of ESSA to provide school-level financial data on our Web site and on the report cards as part of ESSA Plan, the SDE developed a system that was able to collect expenditures at the school level. Over the next year, Ms. Demsey will be working with Chief Performance Officer Ajit Gopalakrishnan as to how to use the data and present it to be meaningful for the Commissioner, parents, local school boards, superintendents, legislatures, and the SDE.

## **IX. Consent Agenda**

Mr. Davenport requested that agenda item IX.A., Report on Agricultural Science and Technology Education Graduates Five Years After Graduation, be removed from the Consent agenda for discussion. Mr. Davenport raised the question and discussion on what was required to have all School Choice programs be required to perform a five-year graduate survey.

Commissioner Cardona thanked Mr. Davenport for his passion on this five-year graduation survey. The Commissioner stated that he was interested in learning more about how to mirror or replicate the graduation surveys for the other Choice schools. Mr. Trefry stated that a graduation survey plan was in the Connecticut Technical Education and Career System Strategic Operating Plan 2019-2020.

**X. Items for Discussion**

**A. Connecticut's Draft Strengthening Career and Technical Education for the 21<sup>st</sup> Century Act (Perkins V) State Plan**

Reading and Literacy Director Dr. Melissa K. Wlodarczyk Hickey presented an overview of Connecticut's Draft Strengthening Career and Technical Education for the 21<sup>st</sup> Century

Act (Perkins V) State Plan to the Board with a PowerPoint. She explained that Perkins V is a principal source of federal funding to states that supports career and technical education (CTE) in secondary schools (high schools) and postsecondary schools (community colleges). Dr. Hickey emphasized that Connecticut's CTE State Plan is in alignment with the Connecticut State Board of Education's Five-year Comprehensive Plan (2016-21): *Ensuring Equity and Excellence for All Connecticut Students* and the Connecticut ESSA Plan. She reviewed the key themes that resonate throughout the Connecticut State Plan and highlighted the deliberate alignment to labor market needs. Dr. Hickey discussed Connecticut's vision regarding: Today's Skill-Tomorrow's Careers. She highlighted the 12 Connecticut Career Clusters that are supported by Perkins V funding. Dr. Hickey reviewed Connecticut's CTE State Plan Timeline.

Discussion followed. The Board thanked Dr. Hickey for her presentation.

## **B. Update on Priorities**

Commissioner Cardona explained to the Board that this month and in some future meetings, he would periodically update them on some progress and priorities as they relate to the Equity and Excellence Plan. He stated that the two focus areas this past month has been (1) Improving Climate/Culture and Student Connectedness; and (2) Strengthening Pathways with the goal of engaging students. The Commissioner invited Deputy Commissioners Charlene Russell-Tucker and Desi Nesmith to speak, respectively.

### Improving Climate/Culture and Student Connectedness

Deputy Commissioner Charlene Russell-Tucker spoke on the strategies of looking at exclusionary practices of suspension and expulsions disproportionately. She highlighted the strategy of the Connecticut School Discipline Collaborative membership and the concept of cross-sector leadership collaboration that is able to design sustainable solutions from working together. Deputy Commissioner discussed next steps for the School Discipline Collaborative such as adding the power of the voice of students in the membership, working on family guides on suspensions and expulsions, learning from districts, and working with other stakeholders. The Connecticut School Discipline Collaborative continues to provide feedback and advise the Commissioner and the State Board of Education concerning strategies in transforming school discipline.

### Strengthening Pathways

Deputy Commissioner Desi Nesmith spoke on the creation of multiple pathways. He emphasized that college and career pathways is preparing for college *and* life beyond experience; it is not one or the other. Deputy Commissioner Nesmith shared and outlined some CSDE pathways:

- Establish workforce development standards for districts to align course work with workforce needs;
- Work with RESC Alliance for best practices because it is important to highlight, replicate and learn from those that are doing it well;

- Expose high school students to higher education possibilities earlier;
- Work in conjunction with the Governor's Workforce Council;
- Work with stakeholders (example of Perkins V); and
- Launch resources for Today's Skills-Tomorrow's Initiative.

Deputy Commissioner Nesmith invited Chief Strategic Planning Officer Keith Norton to share Bacon Academy's manufacturing program in Colchester as an example of a district and community college working together.

## **XI. Committee Reports**

### **A. Academic Standards and Assessment**

Mr. Clemons reported that the Committee met on November 18, 2019, and highlighted discussions on Digital Citizenship, Internet Safety and Media Literacy Guidelines, FAFSA, Summer Melt Research Study, and Lexiles and Quantiles. The next meeting will on February 24, 2020.

### **B. Accountability and Support**

Dr. López reported that the committee would meet on December 11, 2019.

### **C. Finance, Audit, and Budget**

No report was presented.

### **D. Legislation and Policy Development**

Mrs. Benham reported that the committee met that morning. The committee continued a discussion on School Choice, and heard legislative proposals from Chief of Staff Laura Stefon.

### **E. Connecticut Technical Education and Career System Board**

CTECS Chairman Trefry stated that there was nothing further to report at this time since the Strategic Operating Plan presentation in November.

### **F. NASBE**
