A. Agency Update

A. Update on USDA Proposed Nutrition Standards

A panel consisting of Deputy Commissioner Charlene Russell-Tucker, Bureau Chief John Frassinelli, Bureau of Health/Nutrition, Family Services and Adult Education, presented an update on the USDA Nutrition Standards with an overview of the federal rulemaking

process, Healthy Hunger-Free Kids Act of 2010, School Nutrition Landscape from 2010 to now, USDA 2020 Proposed Rule, and the Connecticut Nutrition Environment.

The school meals proposed rule, will empower school nutrition professionals with more flexibility to serve appetizing and healthy meals that appeal to students' preferences and subsequently reduce food waste. The January 23, 2020, USDA Proposed Nutrition Standards had four areas of focus:

- Local program monitoring and review
- o Meal Service (meal items, servings)
- o Competitive Food Sales (a la carte sales)
- o Reimbursable Meals

Mr. Frassinelli had a display tray of food. He demonstrated flexibilities with meal offerings by varying the food adjustments on the tray that could meet the food standards for the cafeteria and classroom.

X. Items for Discussion

A. Report on School Discipline

Deputy Commissioner Charlene Russell-Tucker, Chief Performance Officer Ajit Gopalakrishnan, and Education Division Director Glen Peterson presented a report of analyses of trends in student disciplinary behaviors in Connecticut public schools. Over the past five years, Connecticut has made major strides in reducing exclusionary discipline.

The discussion included data collection, reporting, and the types of disciplinary incidents:

- o In-School Suspension (ISS)
- Out-of-School Suspension (OSS)
- Bus Suspension
- Expulsion (EXP)

All serious offenses and all incidents involving alcohol, drugs, or weapons must be reported. All bullying incidents must also be reported. The behaviors that are associated with the sanctions received by students are grouped into 10 categories. There was a review of:

- Sanctions and Incidents by grade level
- Suspension rates by grades
- o Suspensions of Young Students, Pre-K through Grade 2

Mr. Peterson spoke on alternative community practices.
