Moving Ahead With Common Core

On April 20, 2013, the *New York Times* published an editorial in support of the Common Core State Standards. The editorial board says, "...if the country retreats from the Common Core reforms, it will be surrendering the field to competitors that have already left it behind in math and science education, which are essential to participation in the 21st-century work force." America's Business Leaders Support the Common Core

On February 12, 2013, 73 of America's top business leaders came together and published <u>an open letter</u> <u>in the New York Times</u> declaring their "support [for] these new, tougher academic standards....now under way in America's schools [that] hold great promise for creating a more highly skilled workforce that is better equipped to meet the needs of local, state and national economies."

Videos about the Common Core for Teacher Professional Development

These two videos from the *Teaching Channel* may be informative for <u>math teachers in grades 3-5</u> or <u>English language arts teachers in grades 9-12</u>. Standards Covered: The math standard covered is Math.4.NBT.B.6. The ELA standards covered are ELA.W.11-12.9a, ELA.SL.11-12.1a, and ELA.RL.11-12.1.

The Council of the Great City Schools (CGCS) developed a series of 45-minute videos for educators in English language arts/literacy and mathematics that provide the background of the Common Core State Standards and the six shifts that are inherent in these standards. The videos include David Coleman, Sandra Alberti, Lily Wong Fillmore, and others who helped create the Common Core. Smarter Balanced Practice Test Available May 29, 2013

Smarter Balanced will release a more complete and more broadly available "practice test" starting May 29, 2013. This is a great opportunity for districts that did not participate in the CSDE Common Core aligned "Practice Assessment" to experience items that look like those found on the 2015 Smarter Balanced assessment. One of the benefits to this practice test is that it will include performance tasks, which all districts should try-out this summer. World Languages Instruction Supports Common Core Literacy

The American Council on the Teaching of Foreign Languages (ACTFL) developed a crosswalk document to demonstrate how their National Standards for Learning Languages align with the Common Core State Standards by identifying how each of the standards within each strand are addressed through standards- and performance-based language learning. This document also contains examples of how language students at novice, intermediate, and advanced levels demonstrate the ELA and literacy standards.
