Unallowable Charges to Nonprofit School Food Service Accounts and the Serving

of Meals to Nonpaying Full and Reduced-price Students

The frequency of schools allowing full and reduced-price students who do not have lunch money to charge a meal has increased significantly during recent months. Often the moneys due from these students are never paid, leaving the school food service program with an uncollectible debt.

The United States Department of Agriculture (USDA) has recently issued a reminder to state agencies indicating that "bad debts, including losses (whether actual or estimated) arising from uncollectible accounts and other claims, related collection costs, and related legal costs are **unallowable**." Therefore, funds from the nonprofit school food service account (including dollars received for a la carte sales, catering, etc.) cannot be used to cover the cost of charged meals that have not been paid.

Additionally, there is confusion as to whether schools/districts are required to provide meals to nonpaying full or reduced-price students, as well as what elements need to be included in a charging policy. The USDA is currently reviewing its guidance and more information and recommendations will be forthcoming.

During the interim, the USDA has indicated that schools/districts may opt to provide an alternate meal such as a cheese or peanut butter sandwich at no charge to the student. Since the student is not being offered the required menu items, this type of meal is not reimbursable and the full cost must be borne by the school/district using funds that do not come from the school food service account. Schools/districts may also choose to serve a reimbursable meal to non-paying students so that some funds are received to offset food and labor costs. Schools/districts that are providing meals to non-paying students should establish a written policy on what food will be provided to nonpaying full or reduced-price students as well as their policy on the charging of school meals. Schools/districts must also make this written policy widely available to parents, guardians and students.
