

Connecticut Special Education Due Process Hearing Officers *as of August 2018*

Attorney Ann F. Bird received her B.A. in English and Economics from the University of California at Berkeley in 1979 and her J.D. from the University of California at Davis in 1982. She practiced law in private firms in California and Connecticut until 1994 when she joined the Hartford Corporation Counsel's Office, where she was assigned to represent the Hartford Public Schools. As Assistant and then Senior Assistant Corporation Counsel, Attorney Bird handled all school matters, including special education mediation and due process issues until her retirement in 2008. She has served as an Impartial Hearing Panel for the State Department of Education for expulsion hearings for the Connecticut Technical High School System, school accommodations, residency and transportation hearings and teacher revocation hearings since 2009.

Attorney Susan Dixon has been a practicing attorney for 35 years, representing a diverse variety of clients in family, custody, child abduction and juvenile court matters. She has represented not just adults but also children in court from newborns to the age of majority, in delinquency, neglect and custody cases. She has argued cases at the state and federal level as a trial lawyer and has decided cases as an Attorney Trial Referee and Factfinder. As a parent, Attorney Dixon became directly and extensively involved with the public, private and also the charter school systems.
