# Career Exploration Camp for Deaf and Hard of Hearing Youth, Ages 14 through 17.

Career Exploration Camp is a week long program (August 9-15, 1998) held at Camp Sloan in Lakeville, CT for deaf or hard of hearing youth who live in the Northeast and who wish to explore possible career choices. The goal of the program is to provide each participant with a written assessment which will identify his/her: 1) top 3-5 potential career choices. 2) personality style and learning style, and 3) personal skills, teamwork strengths and areas for improvement.

Participants will attend a series of workshops led by deaf or hard of hearing professionals on how to make career choices and will visit deaf or hard of hearing professionals at their worksites.

Career interest assessments will also be conducted. Participants will have time in which to socialize relax and enjoy the many facilities of the camp including swimming, boating, kayaking, canoeing, volleyball and basketball.

### **Hearing Testing Training**

Connecticut regulations on hearing screening require that personnel conducting such hearings "shall have completed six (6) hours of training in this area including practice supervised by a properly trained school nurse, speech pathologist, or audiologist." To assist staff to meet this requirement, a continuing education program on *Hearing Testing* for school health personnel will be presented on Saturday, May 30, 1998, at the University of Hartford. ### Model Policy and Procedure Manual

In the fall the Bureau of Special Education and Pupil Services presented training to LEAs on IDEA 97 and began the redesign of a Program Review Process which was sensitive to its many changes. It was our plan to develop a procedural safeguards document, an IEP form, and a model policy and procedures manual with the hope that all districts would voluntary adopt them. These documents would be consistent with the IDEA 97 language and state regulations, provide consistency from district to district, and correct the continuing non-compliance status of many districts. To date the SDE has provided a procedural safeguards document and an IEP form for your adoption and use. Our goal was to develop the model policy and procedures manual by the spring.

Since the federal regulations have not been adopted, we decided not to send you the manual at this time, since it would have to be updated upon issuance of the regulations. Therefore, we will provide you with a copy of the manual sometime over the summer; it will include the language of the federal regulations and any newly-passed state statutes. Following the release of the model manual, districts will be given 15 days to indicate whether they will adopt the manual or revise the current manual. Districts who choose the latter option will have an additional 20 days in which to submit the manual to SDE for approval. A more detailed explanation of the process will accompany the model Manual and Checklist when distributed.

Districts undergoing program review this year (CES region) will need to submit documentation of the implementation of IEPs, notices and consents by May 15, 1998. Further information will be sent under a separate letter to these districts.

Please continue to provide feedback regarding the IEP form. A final version will be released with the model manual. Voluntary acceptance of the IEP, model policy and procedures manual and forms as they become available is strongly encouraged. Any changes which a district is proposing to make with regard to standard forms and policy and procedures need to be submitted to SDE for approval.

It is clear that, throughout the state, districts have exerted a "good faith effort" to implement the spirit and letter of IDEA 97. Many districts have already provided extensive training to staff and to families, as well. The draft state IEP form is in widespread use: consent for reevaluation is being requested: progress reporting systems tailored to district's procedures are being discussed: and the writing of measurable annual goals is being practiced. The immediacy of implementation of the amendments.

which has been expected by the Congress, has been a challenge to everyone, and the commitment with which districts are tackling that challenge is evident. You are to be commended for your continued diligence in the implementation of IDEA 97 and your efforts to assure that children with disabilities and their families are well served.

We are convening a committee, with the assistance of CAPSEF, to prepare draft revisions to section 10-76d-15 of the Connecticut Special Education Regulations.. Terri DeFrancis will co-chair this committee. The department also will be represented by Nancy Cappello and Art Carey. CAPSEF will be represented by Elaine Green and Rosemary Baggish, and CONNCASE will be represented by two LEAs. I will keep you posted of their progress.
