
ED-619 PRIMARY PETITION FOR MUNICIPAL OFFICE(S) AT-LARGE

- ❖ A town, city or borough office for which only and <u>all</u> electors of such town, city or borough may vote.
- ❖ State Representative in an Assembly District composed of <u>a single</u> town.
- Judge of Probate in a Probate District of <u>a single town</u>.
- Registrar of Voters



ED-619a PRIMARY PETITION FOR MUNICIPAL OFFICE(S) FROM A POLITICAL SUBDIVISION

- ❖ A town, city or borough office for which only the electors of a political subdivision of such town, city or borough may vote.
- State Representative in an Assembly District composed of a part of a single town.



- Total number of signature need (on page 1 of the instruction page).
- Provide at least 1 instruction page for each circulator.
- Provide 1 or more primary petition pages that can be duplicated
 - If the candidate is indigent, provide at least two times number of signature pages needed to contain the required number of signatures.
- Complete all blanks in Part A of each petition signature pages.
- Certify number of verified signatures and sign in Part E.

Number of Petition Signatures Pages to be provided: Upon completion of the above requirements, the Registrar of Voters shall give to the person requesting the petition form one or more signature pages suitable for duplication as he deems necessary. If the candidate or candidates are indigent, the Registrar shall provide a number of pages determined by such Registrar as at least two times the number sufficient to contain the required number of signatures. The number of signatures required is 370 (being at least 5% of the electors whose names appear on the active last-completed enrollment list of the party in the municipality or such lesser number as the party rules prescribe).







• File verified petitions with Town Clerk and notice of primary (sufficient signatures are verified).

Only statewide and multi-town districts.

- ROV have 7 days to complete verification of signatures.
- Once petition pages are reviewed and signatures verified, forward pages to **SOTS** office.
 - SOTS will tabulate, determine if there are sufficient signatures to qualify candidate and notify ROV and Town Clerks.
