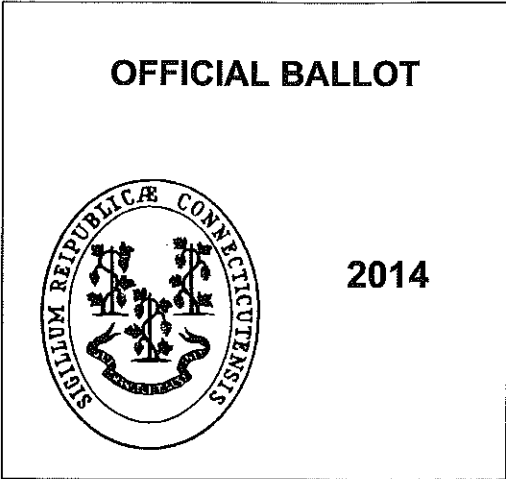

Vote for candidates individually. Do not mark the party names in any way.

II. TO VOTE FOR CANDIDATES.
In most cases, only one mark or write-in vote is allowable in each column (that is, for each office).

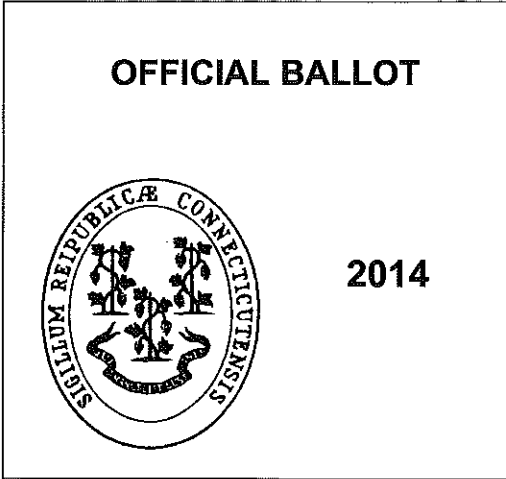
