After careful consideration of your complaint, we decline to consider it further, as it does not allege a potential violation of Elections Law based on the Commission's jurisdiction pursuant to General Statutes § 9-7b.

Specifically, General Statutes § 9-360 does not apply to unsuccessful attempts to vote unlawfully at an election. Further, § 9-360 applies to attempts to unlawfully vote at a primary as opposed to a general election. Nevertheless, the Commission will keep your referral on file should there be future potential violations pertaining Blections Laws by this individual.

Thank you for calling this matter to the Commission's attention. Effectively, your actions and those of your Blections Officials contributed to preventing a potential violation of the law and served to reinforce the systems in place to safe guard elections in Connecticut.
