MERRILL: AT LEAST 16 PRIMARIES IN CONNECTICUT ON AUGUST 9TH

The Secretary of the State announced that registered Republicans and Democrats in a number of towns and cities will have the chance to vote in at least 16 primaries. Primaries will be held for State Senate, State Representative, Judge of Probate and Registrar of Voters. There is no statewide primary on the ballot in 2016, nor is there any primary for federal office.

A full list of primaries is included below.

Secretary Merrill said, "There are exciting races in a number of towns and cities. Please find out if there is a primary where you live and learn about the candidates. Check myvote.ct.gov to ensure your registration is up to date and to find your polling place. You must be enrolled with the party holding the primary to participate."

The deadline to register in person with the town clerk is noon on August 8. The deadline for new or unaffiliated voters to register for the primary by mail is August 4. The mail-in application of new voters must be received by the town registrar—or a voter registration agency or the Department of Motor Vehicles—by August 4.

On August 9, polls will be open for registered Democrats and Republicans from 6:00 a.m. to 8:00 p.m. Voters can visit myvote.ct.gov to learn how to register, check their registration, find their polling locations and download absentee ballot applications.
